CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Estates and Trusts - Orphans' Court - Baltimore City - Pension of Judges**

3 FOR the purpose of increasing the annual pension or salary for certain retired  
4 associate judges of the Orphans' Court for Baltimore City; increasing the annual  
5 pension or salary for certain retired Chief Judges of the Orphans' Court for  
6 Baltimore City; and generally relating to increasing the pension for certain  
7 retired judges of the Orphans' Court for Baltimore City.

8 BY repealing and reenacting, with amendments,  
9 Article - Estates and Trusts  
10 Section 2-108(d)  
11 Annotated Code of Maryland  
12 (1991 Replacement Volume and 2000 Supplement)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article - Estates and Trusts**

16 2-108.

17 (d) (1) (i) Each associate judge of the Court of Baltimore City shall receive  
18 an annual compensation of \$50,000, and the Chief Judge shall receive an annual  
19 compensation of \$60,000.

20 (ii) Each associate judge who was in active service on or after  
21 January 1, [1981] 1984 shall be paid after the termination of active service, if he is

1 then at least 60 years of age or when he shall attain 60 years of age, a pension or  
2 salary calculated at the rate of [~~\$1,500~~] \$2,500 annually for each year, or a part of a  
3 year, of active service; but the maximum pension or salary for the service by an  
4 associate judge may not exceed [~~\$15,000~~] \$25,000 annually. Each Chief Judge who  
5 was in active service on or after January 1, [~~1981~~] 1984, shall be paid, after the  
6 termination of active service, if he is then at least 60 years of age or when he shall  
7 attain 60 years of age, a pension or salary calculated at the rate of [~~\$1,525~~] \$3,000  
8 annually for each year, or a part of a year of active service, but the maximum pension  
9 or salary for the service by a Chief Judge may not exceed [~~\$15,250~~] \$30,000 annually.  
10 The pension or salary shall be paid by the City of Baltimore in the same manner as  
11 the salaries of the judges of the Court for the City are paid.

12           (2)       The surviving spouse of every elected judge of the Court of Baltimore  
13 City shall be paid one half of the pension to which his spouse was entitled at the time  
14 of his death, or would have become entitled to by reason of attaining 60 years of age.  
15 In each instance, the pension shall be paid to the spouse until remarriage or death.  
16 The provisions of this subsection shall not apply in the case of a spouse who was  
17 married to a sitting judge for a period of less than three years prior to his death, and  
18 to a retired judge for a period less than three years before his retirement.

19       SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
20 October 1, 2001.
