A BILL ENTITLED

1 AN ACT concerning

2 **Collection Agencies - Exemption from Regulation**

3 FOR the purpose of exempting from regulation under the collection agency law a
4 certain person who is collecting a debt for another person under certain
5 circumstances; and generally relating to the scope of regulation of the collection
6 agency law.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article - Business Regulation**

15 7-102.

16 This title does not apply to:

- 17 (1) a bank;
- 18 (2) a federal or State credit union;
- 19 (3) a mortgage lender;
- 20 (4) a person acting under an order of a court of competent jurisdiction;
- 21 (5) a licensed real estate broker, or an individual acting on behalf of the
22 real estate broker, in the collection of rent or allied charges for property;
- 23 (6) a savings and loan association;
- 24 (7) a title company as to its escrow business;

1 (8) a trust company; [or]

2 (9) a lawyer who is collecting a debt for a client, unless the lawyer has an
3 employee who:

4 (i) is not a lawyer; and

5 (ii) is engaged primarily to solicit debts for collection or primarily
6 makes contact with a debtor to collect or adjust a debt through a procedure identified
7 with the operation of a collection agency; OR

8 (10) A PERSON WHO IS COLLECTING A DEBT FOR ANOTHER PERSON IF:

9 (I) BOTH PERSONS ARE RELATED BY COMMON OWNERSHIP OR
10 AFFILIATED BY CORPORATE CONTROL;

11 (II) THE PERSON ACTING AS A DEBT COLLECTOR DOES SO ONLY
12 FOR THOSE PERSONS TO WHOM IT IS RELATED BY COMMON OWNERSHIP OR
13 AFFILIATED BY CORPORATE CONTROL; AND

14 (III) THE PRINCIPAL BUSINESS OF THE PERSON ACTING AS A DEBT
15 COLLECTOR IS NOT THE COLLECTION OF DEBTS.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 June 1, 2001.
