## A BILL ENTITLED

## 1 AN ACT concerning

## 2 Homicide - Use of Deadly Force in a Business Establishment - Defense

- 3 FOR the purpose of establishing that a certain person who uses deadly force or force
- 4 likely to cause death within the person's business establishment is presumed to
- 5 have held a reasonable fear of imminent peril of death or serious physical injury
- 6 to the person or an employee of the person's business establishment, if force is
- 7 used against another who unlawfully and forcibly enters or has entered the
- 8 person's business establishment; providing that a person is not civilly liable for
- 9 any act or omission in protecting or attempting to protect the person or an
- employee of the person's business establishment; providing that this Act applies
- to an owner, lessor, or supervisory employee of a business establishment;
- providing for the application of this Act; and generally relating to the use of
- deadly force in a business establishment.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 20 MARYLAND, That the Laws of Maryland read as follows:
- 21 Article 27 Crimes and Punishments
- 22 415A.
- 23 (A) THIS SECTION APPLIES TO AN OWNER, LESSOR, OR SUPERVISORY
- 24 EMPLOYEE OF A BUSINESS ESTABLISHMENT.
- 25 (B) A PERSON WHO USES DEADLY FORCE OR FORCE LIKELY TO CAUSE DEATH
- 26 WITHIN THE PERSON'S BUSINESS ESTABLISHMENT IS PRESUMED TO HAVE HELD A
- 27 REASONABLE FEAR OF IMMINENT PERIL OF DEATH OR SERIOUS PHYSICAL INJURY

- 1 TO THE PERSON OR AN EMPLOYEE OF THE PERSON'S BUSINESS ESTABLISHMENT, IF
- 2 THE FORCE IS USED AGAINST ANOTHER WHO UNLAWFULLY AND FORCIBLY ENTERS
- 3 OR HAS ENTERED THE PERSON'S BUSINESS ESTABLISHMENT.
- 4 (C) A PERSON DESCRIBED IN SUBSECTION (A) OF THIS SECTION IS NOT
- 5 CIVILLY LIABLE FOR ANY ACT OR OMISSION IN PROTECTING OR ATTEMPTING TO
- 6 PROTECT THE PERSON OR AN EMPLOYEE OF THE PERSON'S BUSINESS
- 7 ESTABLISHMENT.
- 8 SECTION 2. AND BE IT FURTHER ENACTED. That this Act shall be
- 9 construed retroactively and shall be applied to and interpreted to affect any action of
- 10 an owner, lessor, or supervisory employee of a business establishment occurring on or
- 11 after January 1, 2001.
- 12 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 13 October 1, 2001.
