#### **FISCAL NOTE**

House Bill 1304(Delegate Benson)Commerce and Government Matters

### Procurement - Bid Protest and Contract Claim Appeals - Award of Attorney and Expert Witness Fees

This bill requires the Board of Contract Appeals to award reasonable attorney and expert witness fees to a contractor under a construction contract, a prospective bidder or offeror, a bidder, or an offeror if the entity: (1) appeals the final action of an agency on a claim under a procurement contract or a protest; and (2) the board sustains the appeal.

### **Fiscal Summary**

**State Effect:** Increase in general and special fund (Transportation Trust Fund) expenditures of approximately \$550,000 in FY 2002. Later years reflect inflation.

#### Analysis

**Current Law:** The Board of Contract Appeals may award reasonable attorney fees to a contractor on a claim resulting from a construction contract if the board finds that the

conduct of the procurement unit personnel in processing the claim is in bad faith or without substantial justification.

The board may not award attorney's fees to a prospective bidder or offeror, a bidder, or an offeror.

**Background:** The Board of Contract Appeals sustains two to four contract disputes and one or two bid protests annually. The board has not awarded any attorney fees.

**State Fiscal Effect:** The Board of Contract Appeals advises that based on the current number of disputes sustained, there would be an increase in general and special fund (Transportation Trust Fund) expenditures of \$550,000 to \$600,000 in fiscal 2002. This amount is expected to increase in future years by the rate of inflation. The board also advises that there is no basis for determining if the new State liability for attorney and expert witness fees would increase the number of bid protests and contract disputes.
