On page 2, strike beginning with "THAT" in line 2 down through "ARTICLE" in line 3.

strike beginning with "AN" in line 15 down through "PROVIDING" in line 16 and substitute "<u>THE</u> <u>STATE, THE FEDERAL GOVERNMENT, OR A COUNTY THAT PROVIDES</u>"; in line 16, after "FACILITY" insert "<u>; OR</u>
