### AMENDMENTS TO SENATE BILL NO. 491

### AMENDMENT NO. 1

On page 1, in the sponsor line, after "Stoltzfus," insert "Teitelbaum,".

### AMENDMENT NO. 2

On page 1, in lines 4, 5, and 7, in each instance, strike "an agency or" and substitute "<u>a</u>"; in lines 9 and 10, strike "requiring funding for major information technology development projects to be provided only through a certain fund;"; in line 14, after "projects" insert "<u>and specifications</u>"; and in line 25, after the first semicolon insert "<u>authorizing the Department of Budget and Management to conduct emergency procurements under certain circumstances; authorizing the Secretary of Budget and Management to create new programs to implement the provisions of this Act;".</u>

#### AMENDMENT NO. 3

On page 2, in line 29, strike the third comma.

On page 3, in line 35, strike "AN".

On page 4, in line 1, strike "AGENCY OR" and substitute "A"; after line 8, insert:

## "(M) (1) "UNIT" MEANS AN AGENCY OR UNIT OF THE EXECUTIVE BRANCH OF STATE GOVERNMENT.

# (2) <u>"UNIT" DOES NOT INCLUDE STATE INSTITUTIONS OF HIGHER</u> <u>EDUCATION."</u>;

in line 10, strike "the Executive Branch of the"; in line 13, strike "AN AGENCY OR" and substitute "A"; in the same line, strike "THE EXECUTIVE BRANCH OF THE"; in line 14, strike "THE DEVELOPMENT OF"; in lines 15 and 16, strike "§§ 3-410.1 AND 3-410.2" and substitute

"§ 3-410.1"; and in line 22, strike "of government in the Executive Branch".

On page 5, in line 18, strike "AGENCY OR"; and in the same line, strike "THE".

### AMENDMENT NO. 4

On page 6, in line 9, strike "THEIR" and substitute "<u>ITS</u>"; in line 10, strike "AN AGENCY OR" and substitute "<u>A</u>"; in the same line, strike "IF THEY" and substitute "<u>PROJECTS WHICH</u>"; in line 12, strike "AGENCY"; in the same line, strike "PROJECTS" and substitute "<u>PROJECT</u>"; in line 13, strike "AN AGENCY'S OR" and substitute "<u>A</u>"; in line 16, after "PROJECTS" insert "<u>AND SPECIFICATIONS</u>"; and strike beginning with "FUNDING" in line 19 down through "FUND" in line 21 and substitute "<u>THE CHIEF SHALL BE RESPONSIBLE FOR OVERSEEING THE IMPLEMENTATION OF MAJOR INFORMATION TECHNOLOGY DEVELOPMENT PROJECTS, REGARDLESS OF FUND SOURCE.</u>

- (E) EXPENDITURES FOR MAJOR INFORMATION TECHNOLOGY DEVELOPMENT PROJECTS SHALL BE SUBJECT TO THE APPROVAL OF THE CHIEF WHO SHALL APPROVE EXPENDITURES ONLY WHEN THOSE PROJECTS ARE CONSISTENT WITH STATEWIDE PLANS, POLICIES, AND STANDARDS.
- (F) (1) THE CHIEF SHALL APPROVE FUNDING FOR MAJOR INFORMATION TECHNOLOGY DEVELOPMENT PROJECTS ONLY WHEN THOSE PROJECTS ARE SUPPORTED BY AN APPROVED SYSTEMS DEVELOPMENT LIFE CYCLE PLAN.
- (2) THE CHIEF MAY APPROVE FUNDING INCREMENTALLY, CONSISTENT WITH THE SYSTEMS DEVELOPMENT LIFE CYCLE PLAN";

and in line 24, after "TECHNOLOGY" insert "DEVELOPMENT".

### AMENDMENT NO. 5

On page 7, in line 8, strike "AND"; in line 10, after "SECTION" insert "; AND

- (6) GENERAL FUNDS APPROPRIATED FOR MAJOR INFORMATION TECHNOLOGY DEVELOPMENT PROJECTS OF ANY UNIT THAT:
- (I) ARE UNENCUMBERED AND UNEXPENDED AT THE END OF A FISCAL YEAR;
  - (II) HAVE BEEN ABANDONED; OR

(III) HAVE BEEN WITHHELD BY THE GENERAL ASSEMBLY OR THE SECRETARY";

in line 28, after the semicolon, insert "AND"; in line 31, strike the semicolon and substitute a period; and strike in their entirety lines 32 through 36, inclusive.

### AMENDMENT NO. 6

On page 8, strike in their entirety lines 1 through 5, inclusive; in line 20, strike the colon; in line 21, strike "(I)"; in the same line, strike "IS SUBMITTED"; in line 22, strike "WHERE" and substitute "FOR WHICH"; in line 23, after "INCREASED" insert "BY MORE THAN 5% OR \$250,000"; strike beginning with "FOR" in line 23 down through "BEEN" in line 26 and substitute "SHALL BE"; in line 27, strike "60-DAY" and substitute "30-DAY"; and in line 28, after "(K)" insert "THE FUND MAY BE USED FOR:

- (1) MAJOR INFORMATION TECHNOLOGY DEVELOPMENT PROJECTS;
  - (2) AS PROVIDED IN SUBSECTION (L) OF THIS SECTION.

On page 9, in line 1, strike "(L)" and substitute " $(\underline{M})$ "; in the same line, strike "ANY AGENCY," and substitute " $(\underline{A})$ "; in the same line, strike the second comma; in line 3, strike "(K)" and substitute " $(\underline{L})$ "; and in line 4, strike "(M)" and substitute " $(\underline{N})$ ".

### AMENDMENT NO. 7

On page 13, in line 25, after "SECTION 4." insert "AND BE IT FURTHER ENACTED, That the Department of Budget and Management is authorized to conduct emergency procurements to obtain the necessary resources to implement the provisions of this Act.

SECTION 5. AND BE IT FURTHER ENACTED, That the Secretary of Budget and Management may create new programs to implement the provisions of this Act.
