AMENDMENTS TO HOUSE BILL NO. 42

(First Reading File Bill)

AMENDMENT NO. 1

In the sponsor line, strike "and Eckardt" and substitute "Eckardt, Mandel, Harrison, Hill, Kirk, Pendergrass, Benson, Bobo, Dembrow, Frush, Grosfeld, Hubbard, Hubers, A. Jones, Malone, Menes, McIntosh, Owings, Morhaim, Minnick, Kach, Walkup, and Klausmeier"; in line 4, strike "a certain number of" and substitute "the scheduled"; strike beginning with "in" in line 4 down through "circumstances" in line 7 and substitute "according to the predetermined work schedule"; in line 8, strike "prescribed work period" and substitute "predetermined work schedule"; strike beginning with "be" in line 9 down through "providing" in line 10 and substitute "exhaust all good faith, reasonable attempts to ensure"; in line 11, strike "prescribed work period" and substitute "predetermined work schedule; exempting certain nurses from certain provisions of this Act"; and strike beginning with "prohibiting" in line 11 down through the second semicolon in line 15.

AMENDMENT NO. 2

On pages 1 and 2, strike in their entirety the lines beginning with line 22 on page 1 down through line 17 on page 2, inclusive.

AMENDMENT NO. 3

On page 2, in line 24, strike "SUBJECT TO SUBSECTION (C)" and substitute "<u>EXCEPT AS PROVIDED IN SUBSECTIONS (C) AND (D)</u>"; strike beginning with the colon in line 25 down through "WORKWEEK" in line 27 and substitute "<u>THE REGULARLY SCHEDULED HOURS</u> ACCORDING TO THE PREDETERMINED WORK SCHEDULE";

in line 28, after "WORK" insert "OVERTIME IF"; and strike in their entirety lines 29 through 34, inclusive.

On page 3, in lines 1 and 3, strike "(I)" and "(II)", respectively, and substitute "(1)" and "(2)", respectively; in line 4, strike "OR CONTRIBUTED TO BY" and substitute "OR AGGRAVATED

BY THE EMPLOYER'S"; in line 5, strike "PLANS BY THE EMPLOYER" and substitute "PLANNING"; in lines 6 and 9, strike "(III)" and "(IV)", respectively, and substitute "(3)" and "(4)", respectively; in line 10, strike "AND"; after line 10, insert:

"(5) THE STANDARD OF CARE FOR A PATIENT ASSIGNMENT REQUIRES
CONTINUITY OF CARE THROUGH COMPLETION OF A CASE, TREATMENT, OR
PROCEDURE; AND";

in line 11, strike "(V)" and substitute "(6)"; in lines 11 and 13, strike "1." and "2.", respectively, and substitute "(I)" and "(II)", respectively; in line 14, strike "UNDER ITEMS (I) THROUGH (IV) OF THIS ITEM" and substitute "LISTED UNDER THIS SUBSECTION"; after line 14, insert:

- "(D) IN ADDITION TO THE PROVISIONS OF SUBSECTION (C) OF THIS SECTION, A NURSE MAY BE REQUIRED TO WORK OVERTIME IF:
 - (1) A CONDITION OF EMPLOYMENT INCLUDES ON-CALL ROTATION;
 - (2) THE NURSE WORKS IN COMMUNITY-BASED CARE.";

in lines 15 and 18, strike "(D)" and "(E)", respectively, and substitute "<u>(E)</u>" and "<u>(F)</u>", respectively; in line 18, after "(1)" insert "<u>EXCEPT AS PROVIDED IN SUBSECTIONS (C) AND (D) OF THIS SECTION</u>,"; in line 19, strike "PRESCRIBED WORK PERIOD" and substitute "<u>PREDETERMINED WORK SCHEDULE</u>"; in line 24, strike "EXCEPT AS PROVIDED IN SUBSECTION (C)(3) OF THIS SECTION,"; in line 25, strike "BE RESPONSIBLE FOR PROVIDING" and substitute "<u>EXHAUST ALL GOOD FAITH, REASONABLE ATTEMPTS TO ENSURE</u>"; in line 27, strike "PRESCRIBED WORK PERIOD" and substitute "<u>PREDETERMINED WORK SCHEDULE</u>"; and strike in their entirety lines 28 through 34, inclusive.

AMENDMENT NO. 4

On page 3, in line 36, strike "July" and substitute "October".
