AMENDMENT NO. 1

On page 1, in line 6, after "Development" insert "<u>regarding the granting of formal recognition</u> <u>of Maryland Indian status to a certain tribe, band, group, or clan</u>"; strike beginning with "propose" in line 8 down through "for" in line 10 and substitute "<u>accept or reject the recommendations made by</u> <u>the Commission on Indian Affairs within a certain period of time; prohibiting</u>"; in line 10, strike "to" and substitute "<u>of</u>"; in line 11, strike "without" and substitute "<u>unless</u>"; in the same line, strike "proposing" and substitute "<u>proposes</u>"; and in the same line, after "order" insert "<u>granting formal</u> <u>recognition</u>".

AMENDMENT NO. 2

On page 2, in lines 33 and 34, strike "SHALL FORMALLY RECOGNIZE" and substitute "SHALL:

(I) GRANT FORMAL RECOGNITION OF MARYLAND INDIAN

<u>STATUS</u>";

in line 34, after "ORDER," insert "<u>TO</u>"; in line 35, after "clan" insert "<u>AS RECOMMENDED BY</u> <u>THE COMMISSION; OR</u>

(II) <u>REJECT THE COMMISSION'S RECOMMENDATION</u>";

and in line 36, strike "promulgated" and substitute "ISSUED".

On page 3, in line 1, after "GOVERNOR" insert "<u>REJECTS THE COMMISSION'S</u> <u>RECOMMENDATION, AND</u>"; in line 3, strike "SHALL RECEIVE" and substitute "<u>MAY NOT</u> <u>BE GRANTED</u>"; in line 4, strike "WITHOUT AN EXECUTIVE ORDER" and substitute "<u>OF</u> <u>MARYLAND INDIAN STATUS UNLESS A SUBSEQUENT APPLICATION IS SUBMITTED</u>

<u>AND APPROVED IN ACCORDANCE WITH THIS SECTION</u>"; and strike in their entirety lines 14 through 18, inclusive.

AMENDMENT NO. 3

On page 3, in line 33, after "That" insert ":

in line 35, after "Commission" insert "<u>on Indian Affairs</u>"; in line 36, after "recognition" insert "<u>of</u> <u>Maryland Indian status</u>"; and in line 37, after "2002" insert "<u>; and</u>

(2) the Governor shall have 120 days from the effective date of this Act to comply with Article 83B, § 5-406(d) of the Code, as enacted by this Act, with respect to an application described under item (1) of this section".
