(a) <u>The Office for Children, Youth, and Families is created as part of the Executive</u> Department.

(b) The head of the Office is the Special Secretary for Children, Youth, and Families. The Special Secretary is appointed by and serves at the pleasure of the Governor and is directly responsible to him. The Special Secretary shall receive the salary provided in the State budget.

(c) The Office shall have a Director and the assistants, fiscal analysts, consultants, and employees provided in the State budget. The Special Secretary may establish areas of responsibility within the Office and may designate staff as necessary to fulfill the duties assigned to the Special Secretary.

- (d) The following units are in the Office:
 - (1) Advisory Committee for Children, Youth, and Families;
 - (2) Children's councils;
 - (3) Governor's Council on Adolescent Pregnancy;

(4) <u>State Coordinating Council for Residential Placement of Handicapped</u> Children; [and]

(5) THE MARYLAND SCHOOL-BASED HEALTH CENTER POLICY ADVISORY COUNCIL; AND

[(5)] (6) Other multiple agency initiatives for children, youth, and families that are not reserved by law to another agency.

(2) MINORITY POPULATIONS OF THE STATE.".

On page 3, in line 5, strike "(E)" and substitute "<u>(C)</u>"; in the same line, after "MEMBER" insert "<u>APPOINTED UNDER SUBSECTION (A) OF THIS SECTION</u>"; in the same line, strike "4" and substitute "<u>3</u>"; in line 6, strike "A MEMBER MAY NOT SERVE MORE THAN TWO CONSECUTIVE TERMS" and substitute "<u>THE TERMS OF MEMBERS ARE STAGGERED AS REQUIRED BY THE TERMS PROVIDED FOR MEMBERS OF THE COUNCIL ON OCTOBER 1, 2002.</u>

(3) AT THE END OF A TERM, A MEMBER SHALL CONTINUE TO SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

(4) <u>A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN</u> SHALL SERVE FOR THE REST OF THE TERM OR UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

(E) FROM AMONG THE MEMBERS OF THE COUNCIL, THE GOVERNOR SHALL DESIGNATE A CHAIRMAN FOR A 2-YEAR TERM";

in line 7, strike "COMMISSION" and substitute "COUNCIL"; and after line 9, insert:

(A) <u>A MAJORITY OF THE MEMBERS THEN SERVING ON THE COUNCIL IS A</u> QUORUM.

(B) THE COUNCIL SHALL DETERMINE THE TIMES AND PLACES OF ITS MEETINGS AND ANY OTHER NECESSARY OPERATING PROCEDURES WHICH MAY INCLUDE THE ESTABLISHMENT OF SUBCOMMITTEES, CONSULTANT PANELS, OR WORK GROUPS UTILIZING THE EXPERTISE OF NONCOUNCIL AND NONPANEL MEMBERS.

(A) THE PURPOSE OF THE COUNCIL IS TO COORDINATE THE INTERAGENCY EFFORT TO DEVELOP, SUSTAIN, AND PROMOTE QUALITY SCHOOL-BASED HEALTH CENTERS IN MARYLAND.

(B) IN CONSULTATION WITH APPROPRIATE STATE AGENCIES AND OTHER INTEREST ORGANIZATIONS, INCLUDING REPRESENTATIVES FROM ACADEMIC INSTITUTIONS, HEALTH CARE PROVIDERS, AND PAYORS, THE COUNCIL SHALL:

(1) MONITOR THE ACTIVITIES AND RANGE OF SERVICES OF THE SCHOOL-BASED HEALTH CENTERS;

(2) <u>RECOMMEND LEGISLATIVE INITIATIVES;</u>

(3) <u>DEVELOP AND UPDATE A COMPENDIUM OF TECHNICAL</u> <u>ASSISTANCE EXPERTS THAT WILL BE USED AS REFERENCE WHEN LOCAL REQUESTS</u> <u>FOR ASSISTANCE COME TO THE STATE;</u>

(4) MONITOR THE DEVELOPMENT OF NOTIFICATIONS OF AVAILABLE FUNDS;

(5) <u>PARTICIPATE IN THE REVIEW OF GRANTS TO LOCAL</u> JURISDICTIONS FOR THE DEVELOPMENT OF SCHOOL-BASED HEALTH CARE <u>PROGRAMS</u>;

(6) <u>DEVELOP STRATEGIES FOR FUNDING AND REIMBURSEMENT OF</u> CARE DELIVERED IN SCHOOL-BASED HEALTH CENTERS;

(7) DEVELOP A CONSISTENT OUTCOME MEASUREMENT TOOL TO BE USED BY ALL SCHOOL-BASED HEALTH CENTERS IN THE STATE AND ASSESS THE PROGRESS OF ALL SCHOOL-BASED HEALTH CENTERS BASED ON THE INFORMATION COLLECTED;

(8) ESTABLISH STANDARDS OF PRACTICE WITHIN SCHOOL-BASED HEALTH CENTERS;

(9) ENCOURAGE THE DEVELOPMENT OF MODELS OF EXCELLENCE IN SCHOOL-BASED HEALTH CENTERS;

(10) PREPARE AN ANNUAL REPORT TO THE SUBCABINET; AND

(11) <u>PERFORM OTHER ACTIVITIES IDENTIFIED THAT IMPACT ON THE</u> <u>DEVELOPMENT, SUSTAINABILITY, OR QUALITY OF SCHOOL-BASED HEALTH CARE IN</u> <u>MARYLAND.</u>".

On pages 3 and 4, strike in their entirety the lines beginning with line 10 on page 3 through line 20 on page 4, inclusive, and substitute:
