## AMENDMENTS TO SENATE BILL NO. 455

(First Reading File Bill)

## AMENDMENT NO. 1

On page 1, in line 2, strike "State Board of Stationary Engineers" and substitute "Board of Examining Engineers"; in line 7, after "Rules;" insert "adding a certain member to the Board of Boiler Rules;"; and in line 11, after "date;" insert "continuing the Board of Examining Engineers in accordance with the provisions of the Maryland Program Evaluation Act (Sunset Law) by extending to a certain date the termination provisions relating to the statutory and regulatory authority of the Board of Examining Engineers;".

On pages 1 and 2, strike beginning with "establishing" in line 11 on page 1 through "Act;" in line 2 on page 2 and substitute "making certain technical corrections;".

On page 2, in line 3, strike "State Board of Stationary Engineers" and substitute "Board of Examining Engineers"; in line 6, strike "169(c)" and substitute "169(a) and (c)"; and strike in their entirety lines 19 through 30, inclusive.

## AMENDMENT NO. 2

On page 3, after line 2, insert:

"(a) There is hereby created within the Division of Labor and Industry a Board of Boiler Rules, referred to hereafter as the "Board", consisting of [9] 11 members, [8] 10 of whom shall be appointed by the Governor with the advice of the Secretary of Labor, Licensing, and Regulation, and with the advice and consent of the Senate. Among the appointed members of the Board shall be 1 representative of the owners and users of power boilers, 1 representative of owners and users of heating boilers, 1 representative of owners and users of pressure vessels, 1 representative of manufacturers or assemblers of boilers or pressure vessels, 1 representative of a company licensed to insure boilers or pressure vessels, 1 mechanical engineer on the faculty of a recognized engineering college within the State, 1 stationary engineer, 1 individual who is licensed as a professional engineer

and has boiler or pressure vessel experience, 1 REPRESENTATIVE FROM THE ANTIQUE BOILER INDUSTRY, and 1 consumer member.";

in line 22, strike "STATE"; in the same line, strike "STATIONARY"; in the same line, strike the brackets; in line 23, strike "2002" and substitute "2004"; and strike beginning with the bracket in line 23 down through "2013" in line 24.

On pages 3 through 20, strike in their entirety the lines beginning with line 25 on page 3 through line 6 on page 20, inclusive.

On page 20, after line 6, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That the Board of Examining Engineers and, as appropriate, the Department of Labor, Licensing, and Regulation shall report to the Senate Education, Health, and Environmental Affairs Committee and the House Economic Matters Committee on or before October 1, 2003, in accordance with § 2-1246 of the State Government Article, on the proposed structure and implementation of a statewide Stationary Engineer Licensing Program.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2002.".
