AMENDMENT TO HOUSE BILL NO. 296

(Third Reading File Bill)

On page 4, in line 26, strike “(I)”; and in lines 30 and 32, strike “1.” and “2.”, respectively, and substitute “(I)” and “(II)”, respectively.

On page 5, in lines 1 and 3, strike “3.” and “4.”, respectively, and substitute “(III)” and “(IV)”, respectively; and in line 35, strike “A STATEMENT OF”.

On page 6, in line 3, strike “A.”; in lines 3 and 4, strike “SUB-SUB-SUBPARAGRAPH B” and substitute “SUB-SUBPARAGRAPH 2”; in line 4, strike “SUB-SUBPARAGRAPH” and substitute “SUBPARAGRAPH”; in line 8, strike “B.” and substitute “2. A.”; in line 9, strike “SUB-SUB-SUBPARAGRAPH A” and substitute “SUB-SUBPARAGRAPH 1”; in line 10, strike “SUB-SUBPARAGRAPH” and substitute “SUBPARAGRAPH”; in line 14, strike “2.” and substitute “B.”; and in line 16, strike “1A” and substitute “1”.

On page 7, in line 3, after “(II)” insert “1.”; in lines 5, 7, 9, and 12, strike “1.”, “2.”, “3. A.”, and “B.”, respectively, and substitute “A.”, “B.”, “C.”, and “2.”, respectively; in lines 9 and 10, strike “SUB-SUB-SUBPARAGRAPH B OF THIS SUB-SUBPARAGRAPH” and substitute “SUB-SUBPARAGRAPH 2 OF THIS SUBPARAGRAPH”; in line 13, strike “SUB-SUB-SUBPARAGRAPH A OF THIS SUB-SUBPARAGRAPH” and substitute “SUB-SUBPARAGRAPH 1C OF THIS SUBPARAGRAPH”; in line 25, after “CONDUCTED” insert “:

(I)”;

and in line 26, strike “AND MAY BE ASSISTED” and substitute “; AND

(II)”.

On page 9, in lines 11, 12, and 15, in each instance, strike “2-201” and substitute “2-104”;

and in lines 25 and 26, strike “(I)” and “(II)”, respectively, and substitute “(1)” and “(2)”, respectively.

On page 12, in line 28, strike “MAY”; in line 33, strike “1.” and substitute “MAY”; and in line 36, strike “2.” and substitute “(II)”.

On page 13, in line 1, after “AGENT,” insert “MAY”; in line 4, strike the period and substitute “; AND”; in line 5, strike “(II)” and substitute “(III)”; in line 7, after “PARAGRAPH,” insert “MAY REQUIRE”; in the same line, strike “SHALL BE REQUIRED”; in line 10, strike the period and substitute a semicolon; in line 11, after “(2)” insert “MAY”; in line 14, after “(3)” insert “MAY”; and in lines 20 and 24, in each instance, strike “§ 2-202” and substitute “§ 2-104”.

On page 14, in line 1, strike “A STATEMENT OF”; in line 2, after “JUSTIFIED;” insert “AND”; in line 5, strike “A.”; in lines 5 and 6, strike “SUB-SUB-SUBPARAGRAPH B OF THIS SUB-SUBPARAGRAPH” and substitute “SUB-SUBPARAGRAPH 2 OF THIS SUBPARAGRAPH”; in line 10, strike “B.” and substitute “2. A.”; in line 11, strike “SUB-SUB-SUBPARAGRAPH A OF THIS SUB-SUBPARAGRAPH” and substitute “SUB-SUBPARAGRAPH 1 OF THIS SUBPARAGRAPH”; in line 16, strike “2.” and substitute “B.”; and in line 18, strike “SUB-SUB-SUBPARAGRAPH A OF THIS SUB-SUBPARAGRAPH” and substitute “SUB-SUBPARAGRAPH 1 OF THIS SUBPARAGRAPH”.

On page 15, in line 7, after “(II)” insert “1.”; in lines 9, 11, and 13, strike “1.”, “2.”, and “3.”, respectively, and substitute “A.”, “B.”, and “C.”, respectively; in lines 13 and 14, strike “SUBPARAGRAPH (III) OF THIS PARAGRAPH” and substitute “SUB-SUBPARAGRAPH 2 OF THIS SUBPARAGRAPH”; in line 16, strike “(III)” and substitute “2.”; in line 17, strike “3” and substitute “1C”; in lines 21 and 23, strike “(IV)” and “(V)”, respectively, and substitute “(III)” and “(IV)”, respectively; in line 29, after “CONDUCTED” insert “:”

(I)”;

and in line 30, strike “AND MAY BE ASSISTED” and substitute “; AND”

(II)”.

On page 17, in line 13, strike “ACT” and substitute “SUBTITLE OR ANY RECOMMENDATIONS FOR ADDITIONAL LEGISLATION THAT MAY BE NECESSARY TO RESPOND TO A CATASTROPHIC HEALTH EMERGENCY”; and in line 16, in each instance, strike “ACT” and substitute “SUBTITLE”.
