On page 1, strike beginning with the second "the" in line 5 down through "purposes" in line 6 and substitute "certain definitions for purposes"; and in line 10, after "credits;" insert "providing that a certain written notification provided by a business entity and accepted as valid by a county or municipal corporation before the effective date of this Act remains in full force and effect;".

#### AMENDMENT NO. 2

On pages 2 and 3, strike beginning with "OR" in line 35 on page 2 through "RENOVATED" in line 1 on page 3.

#### AMENDMENT NO. 3

On page 3, in line 28, strike "A." and substitute "EXPEND AT LEAST \$150 MILLION TO"; in the same line, strike "500,000" and substitute "700,000"; in line 31, strike "OR RENOVATED"; in line 32, strike "B." and substitute "2."; in the same line, strike "AT LEAST 1,000" and substitute "A TOTAL OF AT LEAST 1,100"; and strike beginning with "PAYING" in line 33 down through "PREMISES," in line 38 and substitute "CONSISTING OF BOTH FULL-TIME POSITIONS OF INDEFINITE DURATION AND CONTRACT POSITIONS OF DEFINITE DURATION LASTING AT LEAST 12 MONTHS WITH AN UNLIMITED RENEWAL OPTION, AND INCLUDING AT LEAST 500 INDIVIDUALS IN NEW PERMANENT FULL-TIME POSITIONS, WITH ALL POSITIONS:

A. RECEIVING AN EMPLOYER PROVIDED SUBSIDIZED HEALTH CARE BENEFITS PACKAGE;

B. PAYING AT LEAST 150% OF THE FEDERAL MINIMUM
