#### AMENDMENT NO. 2

On page 12, in lines 7 and 28, in each instance, strike "public schools" and substitute "<u>Public</u> <u>School System</u>"; on page 12 in line 19, and on page 13 in line 6, in each instance, strike "Schools" and substitute "<u>School System</u>"; and on page 14, in line 13, strike "<u>of the</u>" and substitute "<u>or the</u>".
