CHAPTER _____

1 AN ACT concerning

2 **Telephone Lifeline Service - Enhanced Enrollment**

3 FOR the purpose of requiring the Public Service Commission to adopt certain
4 regulations in order to enhance enrollment in the telephone lifeline service by
5 certain methods; requiring the Department of Human Resources, the
6 Department of Housing and Community Development, and the Department of
7 Health and Mental Hygiene, under certain circumstances, to assist the
8 Commission in certain ways; authorizing certain memoranda of understanding;
9 defining certain terms; making a certain technical correction; and generally
10 relating to enhanced enrollment in the telephone lifeline service.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
22 MARYLAND, That the Laws of Maryland read as follows:

Article - Public Utility Companies

2 8-201.

3 (a) (1) In this section the following words have the meanings indicated.

4 (2) ["Telephone lifeline service" means a local telephone service provided
 5 to eligible subscribers that, at a discount, provides an individual residential local
 6 exchange dial access line plus the first 30 residential local untimed messages per
 7 billing month.

8 (3)] "Eligible subscriber" means an individual who is certified to the local
 9 telephone company in whose service area the individual is applying for service by the
 10 Department of Human Resources as receiving:

11 (I) assistance under Article 88A, §§ 44A through 53 of the Code[,
 12 receiving];

13 ~~(II) ASSISTANCE UNDER THE UNIVERSAL SERVICE PROGRAM~~

 18 OR

19 ~~(V)~~ (III) supplemental security income under Title XVI of the
 20 federal Social Security Act.

21 (3) "ENHANCED ENROLLMENT" INCLUDES:

22 (I) DISSEMINATION OF INFORMATION REGARDING THE
 23 TELEPHONE LIFELINE SERVICE, INCLUDING ENROLLMENT PROCEDURES, TO
 24 APPLICANTS AND PARTICIPANTS IN THE MARYLAND ENERGY ASSISTANCE PROGRAM,
 25 THE UNIVERSAL SERVICE PROGRAM, THE MARYLAND MEDICAL ASSISTANCE
 26 PROGRAM, OR THE FOOD STAMP PROGRAM; AND

27 (II) JOINTLY WITH ONE OR MORE OF THE PROGRAMS LISTED
 28 UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH:

29 1. MARKETING THE TELEPHONE LIFELINE SERVICE TO
 30 ELIGIBLE SUBSCRIBERS; AND

31 2. ADMINISTRATION OF THE TELEPHONE LIFELINE
 32 SERVICE'S APPLICATION PROCEDURES AND RELATED MATTERS.

33 (4) "TELEPHONE LIFELINE SERVICE" MEANS A LOCAL TELEPHONE
 34 SERVICE PROVIDED TO ELIGIBLE SUBSCRIBERS THAT, AT A DISCOUNT, PROVIDES AN
 35 INDIVIDUAL RESIDENTIAL LOCAL EXCHANGE DIAL ACCESS LINE PLUS THE FIRST 30
 36 RESIDENTIAL LOCAL UNTIMED MESSAGES PER BILLING MONTH.

1 (E) (1) THE COMMISSION SHALL ADOPT REGULATIONS TO IMPLEMENT
2 ENHANCED ENROLLMENT IN THE TELEPHONE LIFELINE SERVICE.

3 (2) THE DEPARTMENT OF HUMAN RESOURCES, THE DEPARTMENT OF
4 HOUSING AND COMMUNITY DEVELOPMENT, AND THE DEPARTMENT OF HEALTH AND
5 MENTAL HYGIENE:

6 (I) ON REQUEST OF THE COMMISSION, SHALL ASSIST IN THE
7 ADOPTION AND IMPLEMENTATION OF THESE REGULATIONS; AND

8 (II) MAY ENTER INTO MEMORANDA OF UNDERSTANDING WITH THE
9 COMMISSION REGARDING RESPECTIVE DUTIES IN ENHANCED ENROLLMENT
10 MEASURES.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2002.
