- 25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 26 MARYLAND, That the Laws of Maryland read as follows:

HOUSE BILL 151

Article 49D - Office for Children, Youth, and Families 2 29. Subject to the evaluation and reestablishment provisions of the MARYLAND 4 Program Evaluation Act, this article and all rules and regulations adopted under this 5 article shall terminate and be of no effect after July 1, [2004] 2009. **Article - State Government** 7 8-403. On or before December 15 of the 2nd year before the evaluation date of a (a) 9 governmental activity or unit, the Legislative Policy Committee, based on a 10 preliminary evaluation, may waive as unnecessary the evaluation required under this 11 section.

12 (b) Except as otherwise provided in subsection (a) of this section, on or before 13 the evaluation date for the following governmental activities or units, an evaluation 14 shall be made of the following governmental activities or units and the statutes and 15 regulations that relate to the governmental activities or units:

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 19 October 1, 2002.
