2 **Criminal Law - Criminal Penalties - Wharves and Transfer Tickets**

3 FOR the purpose of correcting certain matters identified during statutory revision;
4 repealing minimum fines and setting a maximum fine for violations of the
5 prohibition against giving or receiving certain unauthorized passenger transfer
6 tickets; altering the criminal penalties that may be imposed for interfering with
7 or damaging the usefulness of a public landing or for damaging a public wharf;
8 and generally relating to certain criminal penalties.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
5 MARYLAND, That the Laws of Maryland read as follows:

6 **Article - Criminal Law**

7 8-803.

8 (a) (1) A person may not intentionally issue, sell, or give to an unauthorized
9 person a ticket or instrument for the transfer from a conveyance on one passenger
10 line or route to a conveyance on another line or route of the same or a different carrier.

11 (2) Unless authorized to do so, a person may not intentionally receive a
12 ticket or instrument for the transfer from a conveyance on one passenger line or route
13 to a conveyance on another line or route of the same or a different carrier.

14 (b) A person who violates this section is guilty of a misdemeanor and on
15 conviction is subject to:

16 (1) for the first violation, a fine [not less than \$10 and] not exceeding
17 \$100; and

18 (2) for each subsequent violation, imprisonment not exceeding ~~6 months~~
19 90 DAYS or a fine not [less than \$100] ~~EXCEEDING \$1,000~~ \$500 or both.

22 [(a)] A person may not:

23 (1) Interfere with the use of a public landing;

24 (2) Do anything to destroy the usefulness of the public landing; or

25 (3) Damage a wharf or structure erected on the wharf by the State, a
26 county, or a person under a written agreement with a State unit or a county for public
27 benefit.

28 [(b) A person who violates this section is guilty of a misdemeanor and on
29 conviction is subject to a fine of not less than \$25.]

31 (a) Any person who violates any provision of this title is guilty of a
32 misdemeanor. Upon conviction in a court of competent jurisdiction, unless another
33 penalty is specifically provided elsewhere in this title, the person is subject to a fine

1 not exceeding \$500, with costs imposed in the discretion of the court. Every fine and
2 cost shall be paid in accordance with Article 38, § 4 of the Code.

3 (b) Any person found guilty of a second or subsequent violation of any
4 provision of this title in a court of competent jurisdiction, unless another penalty is
5 specifically provided elsewhere in this title, is subject to a fine not exceeding \$1,000,
6 or imprisonment not exceeding 1 year, or both with costs imposed in the discretion of
7 the court. For the purpose of this subsection, a second or subsequent violation is a
8 violation which has occurred within 2 years of any prior violation of this title.

9 (c) In addition to any administrative penalty provided in this title, violation of
10 any regulation or restriction adopted by any unit within the Department of Natural
11 Resources pursuant to the provisions of this title is a misdemeanor and is punishable
12 as provided in subsections (a) and (b) of this section.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 October 1, 2002.
