2 Calvert County - Fire and Rescue - Length of Service Award Program

- 3 FOR the purpose of repealing a certain limit on the number of members per rescue
- 4 squad or fire department who may receive length of service award program
- 5 credit; altering the designated title used for a fire fighter who may earn credit
- 6 under the length of service award program; and generally relating to the length
- 7 of service award program in Calvert County.

- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, That the Laws of Maryland read as follows:

15 Article 5 - Calvert County

- 17 (a) In order to qualify for any benefits, points shall be credited to each
- 18 volunteer in accordance with the following:
- 19 (1) Five points shall be credited for approved training courses of a
- 20 duration less than 25 hours. Ten points shall be credited for approved training courses
- 21 of a duration of 25 to 49 hours. Fifteen points shall be credited for approved training
- 22 courses of a duration of 50 hours or more. Not more than 30 points may be credited for
- 23 all training each year.
- 24 (2) One point shall be credited for each company or county drill of a
- 25 duration of 2 hours or more. No more than a total of 20 points may be credited for all
- 26 drills each year.

- **HOUSE BILL 264** 1 (3)One point shall be credited for attendance at any official county or 2 company fire or rescue squad meeting. No more than a total of 20 points may be 3 credited for attendance at all meetings each year. 4 One point shall be credited for each call to which a volunteer 5 responds, providing that not more than 40 points may be credited for all calls 6 responded to each year, including standby at a station. 7 Twenty points shall be credited for completion of a 1 year term in an 8 elected or appointed office in any of the fire or rescue service organizations of Calvert 9 County provided that not more than one office shall be counted in any calendar year. 10 One point shall be credited for each hour of acceptable collateral 11 duties, including fund-raising, apparatus and building maintenance, administrative 12 duties, fire prevention, and CPR instruction. No more than 20 points may be credited 13 for all collateral duties performed each year. 14 (7) A volunteer member who serves or has served full time military 15 service in the armed forces of the United States shall receive credit at the rate of 6 16 points for each month served providing that not more than 60 points may be credited 17 for any calendar year. A maximum of 4 years of creditable service may be acquired in 18 this manner. In order to receive this credit a volunteer member must have received an 19 honorable discharge from the armed forces. 20 [Not more than 55 members per rescue squad or fire department 21 combination may receive length of service award program credit in any year. If the 22 membership of a rescue squad or fire department combination exceeds 55, then a 23 maximum of 75 members may receive length of service award program credit in any 24 year. 25 No member with less than 10 years service may earn points unless 26 the member is a certified emergency medical technician or [basic fire fighter] FIRE 27 FIGHTER I. 28 [(10)](9) Points must be earned in at least 4 of 7 categories. 29 In order to provide credit for service prior to January 1, 1986, each 30 company shall review its past and present membership rosters to determine the 31 number of years of credit to which each member or past member is entitled. In 32 making this analysis, the standards for active service shall be used as guidelines. 33 Approval for service shall be certified by the board of directors of each company or 34 rescue squad and as provided in § 14-103 of this subtitle. If a volunteer member has 35 service in more than 1 company or squad that individual shall receive credit for the 36 service in each organization providing not more than 1 year's credits may be granted 37 for each calendar year of volunteer service.
- 38 (c) In the event that sufficient records are unavailable to prove service prior to 39 January 1, 1986, the certification may be made by a company after thorough
- 40 investigation, and on the best information, knowledge and belief of the board of
- 41 directors of the individual company.

- 1 (d) This program shall be funded from the public general funds of Calvert 2 County.
- $3\,$ SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 4 effect October 1, 2002.
