BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 14 MARYLAND, That the Laws of Maryland read as follows: **Article - Financial Institutions** 15 16 3-408. 17 Each director of a commercial bank shall attend at least one half of the (a) 18 regularly scheduled board meetings that are held during the director's term of office. 19 Any director who fails to attend meetings of the board of directors as (b) (1)20 required by this section is disqualified automatically from serving as director for a 21 succeeding term. 22 The Commissioner may waive the disqualification of a director if the (2)23 director shows to the Commissioner good cause for the failure to attend the meetings. 24 NOTWITHSTANDING THE PROVISIONS OF SUBSECTION (B) OF THIS (C) 25 SECTION, THE DISQUALIFICATION OF A DIRECTOR SHALL BE CONSIDERED WAIVED 26 BY THE COMMISSIONER IF: 27 (1)THE FAILURE TO ATTEND RESULTED FROM THE DIRECTOR'S:

	(b) (1) Any director who fails to attend meetings of the board of directors as required by this section is disqualified automatically from serving as director for a succeeding term.
12 13	(2) The Commissioner may waive the disqualification of a director if the director shows to the Commissioner good cause for the failure to attend the meetings.
