A BILL ENTITLED

1 AN ACT concerning

2 **Calvert County - County Officials - Salaries**

3 FOR the purpose of altering the salaries of the County Commissioners of Calvert
4 County, Calvert County Treasurer, Sheriff of Calvert County, and Orphans'
5 Court Judges for Calvert County; providing that this Act does not apply to the
6 salary or compensation of the incumbent County Commissioners of Calvert
7 County, Calvert County Treasurer, Sheriff of Calvert County, or Orphans' Court
8 Judges for Calvert County; and generally relating to the salaries of certain
9 Calvert County officials.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
4 MARYLAND, That the Laws of Maryland read as follows:

5 **Article 5 - Calvert County**

6 2-101.

7 (A) Five county commissioners comprise the Board of County Commissioners
8 of Calvert County.

9 (B) (1) The annual salary of the president of the board is [\$32,500, and the]:

10 (I) \$37,500 FOR CALENDAR YEAR 2002;

11 (II) \$38,500 FOR CALENDAR YEAR 2003;

12 (III) \$39,500 FOR CALENDAR YEAR 2004; AND

13 (IV) \$40,500 FOR CALENDAR YEAR 2005 AND EACH SUBSEQUENT
14 CALENDAR YEAR.

15 (2) THE annual salary of each of the associate members of the board is
16 [\$30,000]:

17 (I) \$35,000 FOR CALENDAR YEAR 2002;

18 (II) \$36,000 FOR CALENDAR YEAR 2003;

19 (III) \$37,000 FOR CALENDAR YEAR 2004; AND

20 (IV) \$38,000 FOR CALENDAR YEAR 2005 AND EACH SUBSEQUENT
21 CALENDAR YEAR.

22 (C) Each commissioner may be reimbursed up to an annual total of \$2,000, for
23 any reasonable costs incurred by the commissioner in carrying out the functions of the
24 office.

25 **Article 25 - County Commissioners**

27 (c) (1) The County Treasurer of Calvert County shall receive an annual
28 salary of [\$37,000]:

29 (I) \$44,000 FOR CALENDAR YEAR 2002;

30 (II) \$44,500 FOR CALENDAR YEAR 2003;

1 (III) \$45,000 FOR CALENDAR YEAR 2004; AND

2 (IV) \$45,500 FOR CALENDAR YEAR 2005 AND EACH SUBSEQUENT
3 CALENDAR YEAR.

4 **Article - Courts and Judicial Proceedings**

6 (f) (1) The Sheriff of Calvert County shall receive an annual salary of
7 [\$51,000]:

8 (I) \$57,000 FOR CALENDAR YEAR 2002;

9 (II) \$59,500 FOR CALENDAR YEAR 2003;

10 (III) \$62,000 FOR CALENDAR YEAR 2004; AND

11 (IV) \$64,500 FOR CALENDAR YEAR 2005 AND EACH SUBSEQUENT
12 CALENDAR YEAR.

13 **Article - Estates and Trusts**

14 2-108.

15 (f) (1) Each of the judges of the Court for Calvert County shall receive as
16 annual compensation the sum of [\$5,000]:

17 (I) \$7,000 FOR CALENDAR YEAR 2002;

18 (II) \$7,250 FOR CALENDAR YEAR 2003;

19 (III) \$7,500 FOR CALENDAR YEAR 2004; AND

20 (IV) \$7,750 FOR CALENDAR YEAR 2005 AND EACH SUBSEQUENT
21 CALENDAR YEAR.

22 (2) The salary of the Chief Judge is [\$5,200]:

23 (I) \$7,200 FOR CALENDAR YEAR 2002;

24 (II) \$7,450 FOR CALENDAR YEAR 2003;

25 (III) \$7,700 FOR CALENDAR YEAR 2004; AND

26 (IV) \$7,950 FOR CALENDAR YEAR 2005 AND EACH SUBSEQUENT
27 CALENDAR YEAR.

28 (3) The County Commissioners may provide additional funds for
29 expenses for the judges.

1 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,
2 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or
3 apply to the salary or compensation of the County Commissioners of Calvert County,
4 Calvert County Treasurer, Sheriff of Calvert County, or Orphans' Court Judges for
5 Calvert County in office on the effective date of this Act, but the provisions of this Act
6 concerning the salary or compensation of the County Commissioners of Calvert
7 County, Calvert County Treasurer, Sheriff of Calvert County, or Orphans' Court
8 Judges for Calvert County shall take effect at the beginning of the next following term
9 of office.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 October 1, 2002.
