- 4 Calvert County Treasurer, Sheriff of Calvert County, or Orphans' Court Judges for
- 5 Calvert County in office on the effective date of this Act, but the provisions of this Act
- 6 concerning the salary or compensation of the County Commissioners of Calvert
- 7 County, Calvert County Treasurer, Sheriff of Calvert County, or Orphans' Court
- 8 Judges for Calvert County shall take effect at the beginning of the next following term
- 9 of office.
