A BILL ENTITLED

1 AN ACT concerning

2 **Creation of a State Debt - Maryland Consolidated Capital Bond Loan of 2002**
3 **and the Maryland Consolidated Capital Bond Loans of 1991, 1992, 1994, 1995,**
4 **1996, 1997, 1998, 1999, and 2001**

5 FOR the purpose of authorizing the creation of a State Debt in the amount of Seven
6 Hundred Twenty-Two Million, One Hundred Ninety-Four Thousand Dollars
7 (\$722,194,000) the proceeds to be used for certain necessary building,
8 construction, demolition, planning, renovation, conversion, replacement, and
9 capital equipment purchases of this State, for acquiring certain real estate in
10 connection therewith, and for grants to certain subdivisions and other
11 organizations for certain purposes, subject to the requirement that certain
12 grantees provide certain matching funds of a certain type by a certain date;
13 providing generally for the issuance and sale of bonds evidencing the loan;
14 providing for certain unexpended appropriations in prior capital budgets and
15 bond loan acts to be expended for other public projects; altering certain
16 requirements for certain programs in prior capital budget acts; providing that
17 the authorizations of State Debt in certain prior capital budgets and bond loan
18 acts be reduced by certain amounts; providing for certain additional information
19 to be detailed about each project in the capital program; and generally relating
20 to the financing of certain capital projects.

- 31 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
32 MARYLAND, That:
- 33 (1) The Board of Public Works may borrow money and incur indebtedness on
34 behalf of the State of Maryland through a State loan to be known as the Maryland
35 Consolidated Capital Bond Loan of 2002 in the total principal amount of
36 \$722,194,000. This loan shall be evidenced by the issuance, sale, and delivery of State
37 general obligation bonds authorized by a resolution of the Board of Public Works and

1 issued, sold, and delivered in accordance with Sections 8-117 through 8-124 of the
2 State Finance and Procurement Article and Article 31, Section 22 of the Code.

3 (2) The bonds to evidence this loan or installments of this loan may be sold as
4 a single issue of bonds under Section 8-122 of the State Finance and Procurement
5 Article.

6 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
7 and first shall be applied to the payment of the expenses of issuing, selling, and
8 delivering the bonds, unless funds for this purpose are otherwise provided, and then
9 shall be credited on the books of the Comptroller and expended, on approval by the
10 Board of Public Works, for the following public purposes, including any applicable
11 architects' and engineers' fees:
