- 3 FOR the purpose of requiring the Executive Director of the Family Investment
- 4 Administration to develop processes to audit certain denials and sanctions, and

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 21 MARYLAND, That the Laws of Maryland read as follows:

22 Article 88A - Department of Human Resources

- 23 1A.
- 24 (a) The Family Investment Administration is established within the
- 25 Department of Human Resources. All of the powers, duties, and responsibilities
- 26 provided for the Social Services Administration in the following programs are
- 27 transferred to the Family Investment Administration: the Family Investment
- 28 Program and related cash benefit programs; public assistance to adults; emergency
- 29 assistance; food stamps; and medical assistance eligibility determinations. References
- 30 to the "Social Services Administration", "State Department", or "State

- 1 Administration" in the laws of this State that concern these programs are deemed to
- 2 mean the Family Investment Administration.
- 3 (b) The Secretary of Human Resources shall appoint an Executive Director of
- 4 Family Investment with the approval of the Governor. The Executive Director shall
- 5 be the head of the Family Investment Administration and shall hold office at the
- 6 pleasure of the Secretary of Human Resources. All powers, duties, and responsibilities
- 7 that pertain to programs transferred to the Family Investment Administration and
- 8 the personnel who administer them which are provided in the laws of this State for
- 9 the State Director of Social Services are transferred to the Executive Director of
- 10 Family Investment.
- 11 (c) The exercise of all authority, duties, and functions vested in the Family
- 12 Investment Administration or the Executive Director of Family Investment under
- 13 this article or any other law of this State shall be subject to the authority of the
- 14 Secretary of Human Resources as set forth in Article 41 of this Code or elsewhere in
- 15 the laws of this State.
- 16 (d) The Executive Director of Family Investment shall:
- 17 (1) Develop a comprehensive process to:
- 18 (i) Systematically analyze cash assistance payment errors AND
- 19 AUDIT APPLICATION AND RECERTIFICATION DENIALS AND SANCTIONS;
- 20 (ii) Formulate strategies, including improvements in the eligibility
- 21 determination process, to reduce the errors, AND INCREASE THE RATE OF
- 22 PARTICIPATION IN THE FOOD STAMP, PURCHASE OF CARE, MEDICAL ASSISTANCE,
- 23 AND ENERGY ASSISTANCE PROGRAMS AMONG THOSE WHO ARE ELIGIBLE; [and]
- 24 (iii) FORMULATE STRATEGIES TO INCREASE COORDINATION WITH
- 25 OTHER STATE AND LOCAL GOVERNMENT AGENCIES THAT PROVIDE SERVICES AND
- 26 SUPPORTS TO LOW INCOME FAMILIES; AND
- 27 (IV) Monitor implementation of the strategies;
- 28 (2) Require each local department of social services to submit annual
- 29 plans that contain measurable objectives, including objectives for participation in
- 30 work activities, [to meet the goals of the family investment program] OBJECTIVES
- 31 FOR INCREASING PARTICIPATION IN THE FOOD STAMP, PURCHASE OF CARE,
- 32 MEDICAL ASSISTANCE, AND ENERGY ASSISTANCE PROGRAMS, AND OBJECTIVES FOR
- 33 OUTREACH;[and]
- 34 (3) [Monitor the success of the local departments of social services in
- 35 achieving the objectives of the plans.] REQUIRE EACH LOCAL DEPARTMENT OF
- 36 SOCIAL SERVICES TO SUBMIT AN ANNUAL REPORT DETAILING ITS SUCCESS IN
- 37 ACHIEVING EACH OBJECTIVE; AND
- 38 (4) MONITOR THE SUCCESS OF EACH LOCAL DEPARTMENT OF SOCIAL

1 (E) THE SECRETARY OF HUMAN RESOURCES SHALL DESIGNATE STAFF OF 2 THE DEPARTMENT OF HUMAN RESOURCES WHO SHALL WORK WITH ADVOCATES 3 AND COMMUNITY PROVIDERS INVITED BY THE SECRETARY TO PARTICIPATE, TO 4 DEVELOP AN OUTREACH CAMPAIGN THAT WILL INCLUDE THE DEVELOPMENT AND 5 DISSEMINATION OF SIMPLIFIED APPLICATION FORMS AND APPROPRIATE OUTREACH 6 MATERIALS THROUGH: 7 COMMUNITY-BASED ORGANIZATIONS; (1) 8 (2) **COMMUNITY PROVIDERS:** 9 STATE AND LOCAL GOVERNMENT AGENCIES, INCLUDING THE (3) 10 OFFICE OF THE COMPTROLLER: AND 11 (4) SCHOOLS. 12 (F) (1) THE SECRETARY OF HUMAN RESOURCES, IN COOPERATION WITH 13 THE DIRECTORS OF LOCAL DEPARTMENTS OF SOCIAL SERVICES, SHALL ESTABLISH A 14 COORDINATED PILOT PROGRAM TO PROVIDE OUTREACH AND OUTPLACEMENT OF 15 LOCAL DEPARTMENT OF SOCIAL SERVICES WORKERS TO ASSIST APPLICANTS TO, 16 AND RECIPIENTS OF BENEFITS UNDER, THE CASH ASSISTANCE, FOOD STAMP, 17 MEDICAL ASSISTANCE, ENERGY ASSISTANCE, AND PURCHASE OF CARE PROGRAMS, 18 IN AT LEAST THREE LOCATIONS, AS FOLLOWS: 19 (I) ONE IN BALTIMORE CITY: 20 (II)ONE IN A SUBURBAN COUNTY; AND 21 (III)ONE IN A RURAL COUNTY. 22 THE DEPARTMENT OF HUMAN RESOURCES SHALL ADOPT 23 REGULATIONS NECESSARY TO IMPLEMENT THE PILOT PROGRAM AND SHALL 24 ENCOURAGE SIGNIFICANT CONSUMER PARTICIPATION AND INVOLVEMENT IN THE 25 IMPLEMENTATION PROCESS. THE SECRETARY SHALL ADOPT REGULATIONS THAT PROVIDE 26 (G) (1) 27 COORDINATED SERVICES TO APPLICANTS TO, AND RECIPIENTS OF BENEFITS UNDER, 28 THE CASH ASSISTANCE, FOOD STAMP, MEDICAL ASSISTANCE, AND THE PURCHASE 29 OF CARE PROGRAMS. THE REGULATIONS SHALL BE DESIGNED TO STREAMLINE THE 30 31 APPLICATION AND RECERTIFICATION PROCESSES, AND RELATED COMPUTER 32 SYSTEMS, INCLUDING: 33 (I) THE ADOPTION OF A SIMPLIFIED APPLICATION PROCESS: THE COORDINATION OF VERIFICATION PROCESSES: AND 34 (II)THE SYNCHRONIZATION OF CERTIFICATION PERIODS TO THE (III)36 MAXIMUM DURATION PERMITTED UNDER FEDERAL LAW.

- 1 (3) THE SECRETARY SHALL ADOPT REGULATIONS TO ENSURE THAT
- 2 APPLICANTS AND RECIPIENTS ARE GIVEN SUFFICIENT OPPORTUNITY TO ESTABLISH
- 3 THEIR ELIGIBILITY FOR EACH PROGRAM, INCLUDING AUTOMATIC SUPERVISOR
- 4 REVIEW OF DENIALS AND EXPEDITED FAIR HEARINGS.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 6 October 1, 2002.
