1 AN ACT concerning

2 **Frederick County - Alcoholic Beverages - Class B Licenses in Middletown**

3 FOR the purpose of authorizing the Board of License Commissioners for Frederick
4 County to issue certain Class B (on-sale) alcoholic beverages licenses within the
5 municipal boundaries of the municipal corporation of Middletown if a certain
6 condition is met; making certain stylistic changes; and generally relating to
7 alcoholic beverages licenses in Frederick County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article 2B - Alcoholic Beverages**

4 8-211.

5 (a) The provisions of this section apply only in Frederick County.

6 (b) A license for the sale of alcoholic beverages authorized by this article may
7 not be issued for any place of business located in any of the following election districts:

8 (1) Catoctin (6th)[,];

9 (2) Hauvers (10th)[,];

10 (3) Jackson (16th)[,];

11 (4) Linganore (19th)[,];

12 (5) Tuscarora (21st)[,]; and

13 (6) Ballenger (23rd).

14 (c) Class A, B, and C licenses for the sale of beer only, as authorized by this
15 article, shall be issued for places of business located in any of the following election
16 districts:

17 [Middletown (3rd),]

18 (1) Jefferson (14th)[,];

19 (2) Johnsville (17th)[,]; and

20 (3) Burkittsville (22nd).

21 (d) Class A, B, and C licenses for the sale of beer and light wine and A, B, and
22 C licenses for the sale of beer, wine and liquor, as authorized by this article, shall be
23 issued for places of business located in any of the following election districts:

24 (1) Buckeystown (1st)[,];

25 (2) Frederick (2nd)[,];

26 (3) Creagerstown (4th)[,];

27 (4) Emmitsburg (5th)[,];

28 (5) Urbana (7th)[,];

29 (6) Liberty (8th)[,];

- 1 (7) New Market (9th)[,];
2 (8) Woodsboro (11th)[,];
3 (9) Petersville (12th)[,];
4 (10) Mt. Pleasant (13th)[,];

11 (D-1) (1) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE WITHIN THE
12 MUNICIPAL BOUNDARIES OF THE MUNICIPAL CORPORATION OF MIDDLETOWN:

13 (I) CLASS A, B, OR C BEER LICENSES; OR

14 (II) CLASS B BEER, WINE AND LIQUOR (ON-SALE) LICENSES IF THE
15 LICENSED PREMISES DERIVE AT LEAST 70% OF ITS MONTHLY GROSS REVENUE FROM
16 THE SALE OF FOOD.

17 (2) IN ALL OTHER AREAS OF THE MIDDLETOWN (3RD) ELECTION
18 DISTRICT, THE BOARD OF LICENSE COMMISSIONERS MAY ONLY ISSUE CLASS A, B, OR
19 C BEER LICENSES.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 July 1, 2002.
