## 1 AN ACT concerning

## 2 Labor and Employment - Employee Leave for Adoptions - Sunset Repeal

- 3 FOR the purpose of repealing a termination provision relating to leave required to be
- granted by an employer when a child is placed with an employee for adoption;
- 5 and generally relating to employee leave for adoption purposes.

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

## 1 Article - Labor and Employment

- 2 3-801.
- 3 (a) In this subtitle, "employer" means a person engaged in a business, 4 industry, profession, trade, or other enterprise in the State.
- 5 (b) "Employer" includes:
- 6 (1) a unit of State or local government that employs individuals who are 7 not subject to the provisions of Title 9, Subtitle 5 of the State Personnel and Pensions 8 Article; and
- 9 (2) a person who acts directly or indirectly in the interest of another 10 employer with an employee.

- 12 (a) This subtitle applies to an employer who provides leave with pay to an 13 employee following the birth of the employee's child.
- 14 (b) An employer who provides leave with pay to an employee following the
- 15 birth of the employee's child shall provide the same leave with pay to an employee
- 16 when a child is placed with the employee for adoption.

## Chapter 503 of the Acts of 1999

- 18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 19 July 1, 1999. [It shall remain effective for a period of three years and, at the end of
- 20 June 30, 2002, with no further action required by the General Assembly, this Act shall
- 21 be abrogated and of no further force and effect.]
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 23 June 1, 2002.
