A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County - Education - Home and Hospital Teacher**
3 **Representation and Junior Reserve Officer Training Corps Instructors**
4 **PG 403-02**

5 FOR the purpose of including Prince George's County home and hospital teachers and
6 Junior Reserve Officer Training Corps (JROTC) instructors in the definition of
7 "public school employees" for the purpose of certain provisions of law related to
8 organizations of certificated employees; and generally relating to representation
9 for home and hospital teachers and JROTC instructors in Prince George's
10 County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article - Education**

19 6-401.

20 (a) In this subtitle the following words have the meanings indicated.

21 (b) "Employee organization" means an organization that:

22 (1) Includes certificated employees of a public school employer or
23 individuals of equivalent status in Baltimore City; and

24 (2) Has as one of its main purposes the representation of the employees
25 in their relations with that public school employer.

1 (c) (1) "Home and hospital teacher" means a teacher employed by a public
2 school employer to provide instructional services to a public school student who is
3 unable to function effectively in the classroom setting due to the student's medical,
4 physical, or emotional condition.

5 (2) A home and hospital teacher may teach in:

6 (i) A private home;

7 (ii) A hospital;

8 (iii) A therapeutic center;

9 (iv) A school; or

10 (v) Any other appropriate site.

11 (d) (1) "Public school employee" means a certificated professional individual
12 who is employed by a public school employer or an individual of equivalent status in
13 Baltimore City, except for a county superintendent or an individual designated by the
14 public school employer to act in a negotiating capacity as provided in § 6-408(b) of
15 this subtitle.

16 (2) In Montgomery County, "public school employees" include:

17 (i) Certificated and noncertificated substitute teachers employed
18 by the public school employer for at least 7 days before March 1 of the school fiscal
19 year ending June 30, 1978, and each year after; and

20 (ii) Home and hospital teachers employed by the public school
21 employer for at least 7 days before March 1 of the school fiscal year ending June 30,
22 2000, and each year after.

23 (3) In Baltimore County, "public school employee" includes a secondary
24 school nurse, an elementary school nurse, and a special school nurse.

25 (4) In Frederick County, "public school employee" includes a social
26 worker employed by a public school employer.

27 (5) IN PRINCE GEORGE'S COUNTY "PUBLIC SCHOOL EMPLOYEE"
28 INCLUDES HOME AND HOSPITAL TEACHERS AND JUNIOR RESERVE OFFICER
29 TRAINING (JROTC) INSTRUCTORS.

30 (e) "Public school employer" means a county board of education or the New
31 Baltimore City Board of School Commissioners.

32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
33 October 1, 2002.
