1 2	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 14 SECTION 2. AND BE IT FURTHER ENACTED, That all policies, contracts,
- 15 and health benefit plans subject to the provisions of this Act shall make the benefits
- 16 under this Act available on and after its effective date, notwithstanding any
- 17 statement in the policy, contract, or health benefit plan to the contrary this Act shall
- 18 apply to all policies, contracts, and health benefit plans issued, delivered, or renewed
- 19 in the State on or after October 1, 2002.
- 20 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 21 October 1, 2002.
