- 12 ADVERTISEMENT BY A LICENSED REAL ESTATE SALESPERSON, LICENSED
- 13 ASSOCIATE REAL ESTATE BROKER, OR OTHER PERSON ON BEHALF OF A LICENSED
- 14 REAL ESTATE SALESPERSON OR LICENSED REAL ESTATE BROKER.
- 15 (3) (I) "ADVERTISEMENT" MEANS, UNLESS THE CONTEXT REQUIRES
- 16 OTHERWISE, ANY ORAL, WRITTEN, OR PRINTED MEDIA ADVERTISEMENT.
- 17 (II) "ADVERTISEMENT" INCLUDES ANY CORRESPONDENCE,
- 18 MAILING, NEWSLETTER, BROCHURE, BUSINESS CARD, FOR SALE OR FOR LEASE SIGN
- 19 AND SIGN RIDER, PROMOTIONAL ITEM, AUTOMOBILE SIGNAGE, TELEPHONE

- 26 (II) "TRADE NAME" INCLUDES A FIRST NAME, NICKNAME, OR LAST
- 27 NAME OR THE NAME OF A JOINT VENTURE, PARTNERSHIP, CORPORATION, OR
- 28 LIMITED LIABILITY COMPANY.
- 29 (B) A LICENSED REAL ESTATE SALESPERSON OR LICENSED ASSOCIATE REAL
- 30 ESTATE BROKER MAY NOT ADVERTISE UNLESS:
- 31 (1) THE NAME OR TRADE NAME OF THE LICENSED REAL ESTATE
- 32 SALESPERSON OR LICENSED ASSOCIATE REAL ESTATE BROKER, AS THE NAME OR
- 33 TRADE NAME APPEARS ON THE LICENSE CERTIFICATE AND POCKET CARD ISSUED BY
- 34 THE COMMISSION, IS MEANINGFULLY AND CONSPICUOUSLY INCLUDED IN THE

- 36 (2) THE NAME OF THE BUSINESS WITH WHICH THE LICENSED REAL
- 37 ESTATE SALESPERSON OR LICENSED ASSOCIATE REAL ESTATE BROKER IS

- 1 AFFILIATED IS MEANINGFULLY AND CONSPICUOUSLY INCLUDED IN THE

- 4 (A) A LICENSED REAL ESTATE SALESPERSON OR LICENSED ASSOCIATE REAL
- 5 ESTATE BROKER MAY PROVIDE REAL ESTATE BROKERAGE SERVICES UNDER A
- 6 TRADE NAME THAT HAS BEEN APPROVED BY THE COMMISSION.
- 7 (B) SUBJECT TO THE APPROVAL OF THE COMMISSION, A LICENSED REAL
- 8 ESTATE SALESPERSON OR LICENSED ASSOCIATE REAL ESTATE BROKER MAY ADD A
- 9 TRADE NAME ON A LICENSE CERTIFICATE AND POCKET CARD IF THE LICENSEE
- 10 SUBMITS TO THE COMMISSION:
- 11 (1) AN APPLICATION ON THE FORM THAT THE COMMISSION PROVIDES;
- 12 (2) THE LICENSE CERTIFICATE AND POCKET CARD OF THE LICENSEE;
- 13 (3) ANY DOCUMENTATION ABOUT THE TRADE NAME THAT THE
- 14 COMMISSION REQUIRES; AND
- 15 (4) A FEE OF \$5.
- 16 (C) THE FULL LEGAL NAME OF THE LICENSEE AND THE APPROVED TRADE
- 17 NAME SHALL BE DISPLAYED ON THE NEW LICENSE CERTIFICATE AND POCKET CARD.
