- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 22 MARYLAND, That the Laws of Maryland read as follows:

- 26 (i) "Program" means the Maryland Medical Assistance Program.

- 2 (A) IF THE DEPARTMENT APPLIES FOR A MEDICAL ASSISTANCE PROGRAM
- 3 WAIVER OR MODIFIES OR AMENDS AN EXISTING MEDICAL ASSISTANCE PROGRAM
- 4 WAIVER, THE DEPARTMENT SHALL GIVE NOTICE OF THE APPLICATION BY
- 5 PUBLICATION IN THE MARYLAND REGISTER.
- 6 (B) FOR 30 DAYS FOLLOWING PUBLICATION OF ANY NOTICE PUBLISHED 7 UNDER SUBSECTION (A) OF THIS SECTION, THE DEPARTMENT SHALL:
- 8 (1) MAKE THE MEDICAL ASSISTANCE PROGRAM WAIVER APPLICATION
- 9 AVAILABLE TO THE PUBLIC DURING BUSINESS HOURS; AND
- 10 (2) PROVIDE AN OPPORTUNITY TO RECEIVE PUBLIC COMMENTS ON THE
- 11 MEDICAL ASSISTANCE PROGRAM WAIVER APPLICATION.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
