A BILL ENTITLED

1 AN ACT concerning

2 **Washington Suburban Sanitary Commission - Pretreatment Program -**  
3 **Citations and Complaints**  
4 **PG/MC 105-02**

5 FOR the purpose of authorizing the Washington Suburban Sanitary Commission to  
6 adopt regulations governing the WSSC Pretreatment Program; making  
7 violations of certain pretreatment standards by certain users a WSSC infraction  
8 under the jurisdiction of the District Court; altering a provision of law to  
9 authorize rather than require the Commission to issue a written complaint  
10 under certain circumstances; altering a certain definition; making a stylistic  
11 change; and generally relating to the Washington Suburban Sanitary  
12 Commission Pretreatment Program.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
24 MARYLAND, That the Laws of Maryland read as follows:

25 **Article 29 - Washington Suburban Sanitary District**

26 18-104.2.

27 (a) In this section the following words have the meanings indicated.

1 (1) "Enforcement official" means an employee of WSSC authorized by  
2 WSSC to issue a citation for a WSSC infraction under this section.

3 (2) "Regulations" means the regulations of the Washington Suburban  
4 Sanitary Commission governing:

5 (i) Erosion and sediment control for utility construction in Prince  
6 George's and Montgomery counties;

7 (ii) Plumbing, gas fitting, and sewer cleaning in the Washington  
8 Suburban Sanitary District; [or]

9 (iii) Required permits for public utility construction in the sanitary  
10 district; OR

11 (IV) STATE PRETREATMENT REQUIREMENTS FOR INDUSTRIAL  
12 USERS.

13 (3) "Repeated infraction" means a recurring violation of the same  
14 provision of the regulations by the same person.

15 (4) "WSSC infraction" means a violation of the regulations.

16 (b) (1) The WSSC is authorized to adopt the regulations as follows:

17 (i) Regulations governing erosion and sediment control for utility  
18 construction, under authority of § 9-101 of this article and § 4-105 of the  
19 Environment Article, and after review and approval by the soil conservation districts  
20 of Prince George's and Montgomery counties and the Department of Natural  
21 Resources;

22 (ii) Regulations governing sewer cleaning, under authority of §  
23 3-301 of this article;

24 (iii) Regulations governing plumbing, under authority of §§ 8-104,  
25 9-101, 14-102, and 15-104 of this article;

26 (iv) Regulations governing gas fitting, under authority of § 9-102 of  
27 this article; [and]

28 (v) Regulations governing required permits for public utility  
29 construction, under authority of §§ 10-104 and 10-105 of this article; AND

30 (VI) REGULATIONS GOVERNING THE WSSC PRETREATMENT  
31 PROGRAM, UNDER AUTHORITY OF § 9-101 OF THIS ARTICLE AND § 9-332 OF THE  
32 ENVIRONMENT ARTICLE.

33 (2) The regulations shall be published as provided in § 9-101(b) of this  
34 article.

1 (3) The sworn certificate of any member of the WSSC of the publication  
2 under this section is prima facie evidence of publication.

4 (a) In this [section] SECTION, "WSSC Pretreatment Program" means any  
5 program adopted under authority of § 9-332 of the Environment Article and § 9-101  
6 of this article to:

7 (1) Meet national pretreatment requirements;

8 (2) Meet local pretreatment requirements; and

9 (3) Eliminate the contribution of each pollutant discharged from an  
10 industrial user into a publicly owned treatment works that:

11 (i) Causes pass through or interference with the publicly owned  
12 treatment works; or

13 (ii) Contaminates sewage sludge.

14 (b) (1) The WSSC [shall] MAY issue a written complaint if the WSSC has  
15 reasonable grounds to believe that the person to whom the complaint is directed has  
16 violated any provision of the WSSC Pretreatment Program.

17 (2) A complaint issued under this subsection shall:

18 (i) Specify the provision of the WSSC Pretreatment Program that  
19 allegedly has been violated; and

20 (ii) State the alleged facts that constitute the violation.

21 **Article - Courts and Judicial Proceedings**

23 Except as provided in § 4-402 of this subtitle, and subject to the venue  
24 provisions of Title 6 of this article, the District Court has exclusive original civil  
25 jurisdiction in:

26 (10) A proceeding for adjudication of:

27 (iv) A WSSC infraction as defined in Article 29, § 18-104.2 of the  
28 Code, concerning WSSC regulations governing:

29 1. Erosion and sediment control for utility construction;

30 2. Plumbing, gas fitting, and sewer cleaning; [and]

31 3. Required permits for utility construction; AND
