12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

## Article - Insurance

16 (d) A private review agent may not render an adverse decision as to an 17 admission of a patient during the first [24] 72 hours after admission when:

18 (1) the admission is based on a determination that the patient is in 19 imminent danger to self or others;

20 (2) the determination has been made by the patient's physician or 21 psychologist in conjunction with a member of the medical staff of the facility who has
22 privileges to make the admission; and
(3) the hospital immediately notifies the private review agent of:
(i) the admission of the patient; and
(ii) the reasons for the admission.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 2 October 1, 2002.
