4 FOR the purpose of requiring an organization that solicits a person for certain

- 5 support or resources to inform the person in writing if the organization is
- 6 designated as a terrorist organization under a certain federal law or if the
- 7 organization is controlled by a terrorist organization; prohibiting a person from
- 8 soliciting certain support or resources for a terrorist organization or an
- 9 organization controlled by a terrorist organization under certain circumstances;
- 10 prohibiting a person from knowingly providing certain support or resources to a
- 11 terrorist organization or an organization controlled by a terrorist organization
- 12 under certain circumstances; defining certain terms; providing a penalty; and

7 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS 8 INDICATED.

9 (2) (I) "MATERIAL SUPPORT OR RESOURCES" MEANS:

101.CURRENCY, MONETARY INSTRUMENTS, OR FINANCIAL11SECURITIES, FINANCIAL SERVICES, LODGING, SAFEHOUSES, FALSE

12 DOCUMENTATION OR IDENTIFICATION, COMMUNICATIONS EQUIPMENT, FACILITIES, 13 WEAPONS, LETHAL SUBSTANCES, EXPLOSIVES, OR TRANSPORTATION; OR

142.PERSONNEL, TRAINING, OR PROFESSIONAL ADVICE15RELATING TO OR SUPPORTING TERRORIST ACTIVITIES.

16 (II) "MATERIAL SUPPORT OR RESOURCES" DOES NOT INCLUDE
17 WRITTEN OR RECORDED MATERIALS INTENDED TO EXPRESS POLITICAL OR
18 RELIGIOUS VIEWS OR TO PROVIDE INFORMATION UNRELATED TO TERRORIST
19 ACTIVITY.

20 (3) "TERRORIST ORGANIZATION" MEANS AN ORGANIZATION THAT IS 21 DESIGNATED AS A FOREIGN TERRORIST ORGANIZATION IN ACCORDANCE WITH 8 22 U.S.C. § 1189.

(B) AN ORGANIZATION THAT SOLICITS MATERIAL SUPPORT OR RESOURCES24 FROM A PERSON SHALL INFORM THAT PERSON IN WRITING IF THE ORGANIZATION IS:

25 (1) A TERRORIST ORGANIZATION; OR

26 (2) CONTROLLED BY A TERRORIST ORGANIZATION.

27 (C) A PERSON MAY NOT SOLICIT MATERIAL SUPPORT OR RESOURCES FOR AN 28 ORGANIZATION THAT THE PERSON KNOWS IS:

29 (1) A TERRORIST ORGANIZATION; OR

30 (2) CONTROLLED BY A TERRORIST ORGANIZATION UNLESS THE PERSON
 31 RECEIVES A WRITTEN ASSURANCE THAT THE SUPPORT OR RESOURCES WILL NOT BE
 32 TRANSFERRED TO THE TERRORIST ORGANIZATION OR EXPENDED ON ITS BEHALF.

33 (D) A PERSON MAY NOT KNOWINGLY PROVIDE MATERIAL SUPPORT OR
 34 RESOURCES TO AN ORGANIZATION THAT THE PERSON KNOWS IS:

1 (1) A TERRORIST ORGANIZATION; OR

(2) CONTROLLED BY A TERRORIST ORGANIZATION UNLESS THE PERSON

5 (E) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY AND ON
6 CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 10 YEARS OR A FINE
7 NOT EXCEEDING \$10,000 OR BOTH.

8 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 October 1, 2002.
