## 2 Circuit Courts - Rental of Space for Clerks of Court

- 3 FOR the purpose of requiring each State budget to include a certain appropriation to
- 4 the Department of General Services to pay rent to counties, including Baltimore
- 5 City, for certain space occupied by clerks of the circuit courts; establishing the
- 6 amount of the rent; prohibiting reimbursement of certain costs; prohibiting a
- 7 county from decreasing the square footage allocated to the clerk of the circuit
- 8 court below a certain amount, unless the county and the Administrative Office
- 9 of the Courts agree otherwise; requiring counties to use the savings resulting
- 10 from this Act for the circuit courts or related public safety purposes; requiring
- certain reports on certain expenditures; providing for the construction of this
- 12 Act; and generally relating to rental of space for clerks of the circuit courts.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 19 MARYLAND, That the Laws of Maryland read as follows:
- 20 Article Courts and Judicial Proceedings
- 21 1-504.
- 22 (A) THERE SHALL BE INCLUDED IN EACH STATE BUDGET AN APPROPRIATION
- 23 TO THE DEPARTMENT OF GENERAL SERVICES IN THE TOTAL AMOUNT NECESSARY
- 24 TO PAY RENT DIRECTLY TO COUNTIES FOR SPACE OCCUPIED IN COUNTY FACILITIES
- 25 BY CLERKS OF THE CIRCUIT COURTS, AS PROVIDED IN THIS SECTION.
- 26 (B) THE RENT SHALL BE \$10 PER NET USABLE SQUARE FOOT, WITH NO
- 27 ADDITIONAL REIMBURSEMENT OF MAINTENANCE AND UTILITY COSTS.

- 1 (C) UNLESS THE ADMINISTRATIVE OFFICE OF THE COURTS AND A COUNTY
- 2 AGREE OTHERWISE, THE COUNTY MAY NOT DECREASE THE NET USABLE SQUARE
- 3 FOOTAGE ALLOCATED TO THE CLERK OF THE CIRCUIT COURT FOR THE COUNTY
- 4 BELOW THE NET USABLE SQUARE FOOTAGE ALLOTTED FOR FISCAL YEAR 2002.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That, except as expressly
- 6 provided in this Act, this Act does not modify any existing duty, liability, or
- 7 responsibility of the State, a county, or Baltimore City.

## 8 SECTION 3. AND BE IT FURTHER ENACTED, That:

- 9 (1) Beginning in fiscal year 2003 and each fiscal year thereafter, each county 10 and Baltimore City shall use the savings resulting from this Act solely to increase
- 11 local expenditures for the circuit courts or related public safety purposes;
- 12 (2) In fiscal years 2003 through 2010, each county and Baltimore City shall
- 13 report to the Department of Budget and Management on or before November 1 on
- 14 circuit court or related public safety expenditures to which the savings resulting from
- 15 this Act have been applied. The Department of Budget and Management shall report
- 16 these expenditures to the Chief Judge of the Court of Appeals and, subject to § 2-1246
- 17 of the State Government Article, to the General Assembly; and
- 18 (3) Circuit court or related public safety expenditures required under this
- 19 section shall be used to supplement and may not supplant existing local expenditures
- 20 for the same purpose.
- 21 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 22 July 1, 2002.
