## **Public Safety - Correctional Institutions - Telephone Contracts** 3 FOR the purpose of prohibiting certain contracts that provide telephone service for inmates from providing for the State or a local government to receive a certain commission or revenue under certain circumstances; prohibiting the State or a local government from receiving certain commissions or revenue from certain contracts; requiring a certain reduction in charges for inmate telephone calls under certain circumstances; providing for the application of this Act; and generally relating to contracts for inmate telephone calls. 10 BY adding to Article - Correctional Services Section 8-901 to be under the new subtitle "Subtitle 9. Inmate Telephone Contracts" Annotated Code of Maryland (1999 Volume and 2001 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That the Laws of Maryland read as follows: **Article - Correctional Services** SUBTITLE 9. INMATE TELEPHONE CONTRACTS. 20 8-901. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, FOR ANY CONTRACT (A) 22 ENTERED INTO BY THE STATE AND A LOCAL GOVERNMENT WITH A 23 TELECOMMUNICATION SERVICE PROVIDER TO PROVIDE TELEPHONE SERVICE FOR 24 INMATES: THE CONTRACT MAY NOT PROVIDE FOR THE STATE OR A LOCAL (1)26 GOVERNMENT TO RECEIVE ANY COMMISSION OR OTHER FORM OF REVENUE; AND

1 (2) THE STATE OR A LOCAL GOVERNMENT MAY NOT RECEIVE ANY 2 COMMISSION OR OTHER FORM OF REVENUE.

3 (B) FOR ANY REDUCTION IN THE COST OF A CONTRACT DESCRIBED UNDER
4 SUBSECTION (A) OF THIS SECTION, THE STATE OR A LOCAL GOVERNMENT SHALL
5 ENSURE THAT THE REDUCTION IS REASONABLY REFLECTED IN THE CHARGES FOR

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply only
to contracts for telephone service entered into on or after June 1, 2002, and may not
be construed to affect a contract entered into before June 1, 2002.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 June 1, 2002.
