- 21 (A) IN THIS SECTION, "LOCAL LAW ENFORCEMENT AGENCY" MEANS A POLICE
- 22 DEPARTMENT OR SHERIFF, AS DESIGNATED BY A COUNTY OR MUNICIPAL
- 23 CORPORATION, WITH JURISDICTION OVER THE LOCATIONS OF VENDING MACHINES
- 24 OF A VENDING MACHINE COMPANY IN THE COUNTY OR MUNICIPAL CORPORATION.
- 25 (B) IN ORDER TO FACILITATE LOCAL LAW ENFORCEMENT RESPONSE TO THE
- 26 THEFT OF MONEY OR MERCHANDISE FROM VENDING MACHINE COMPANY VANS, A
- 27 LOCAL LAW ENFORCEMENT AGENCY MAY REGISTER THE VANS OF A VENDING

- 3 (C) THE REGISTRATION OF VANS WITH THE LOCAL LAW ENFORCEMENT
- 4 AGENCY UNDER THIS SECTION IS AT THE OPTION OF THE VENDING MACHINE
- 5 COMPANY.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 7 October 1, 2002.
