- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

- 18 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
- 19 INDICATED.
- 20 (2) "ASSESSED VALUE OF TAXABLE PROPERTY" MEANS THE MOST
- 21 RECENT ESTIMATE MADE BY THE DEPARTMENT OF ASSESSMENTS AND TAXATION
- 22 BEFORE THE STATE BUDGET IS SUBMITTED TO THE GENERAL ASSEMBLY, OF THE
- 23 ASSESSED VALUE OF PROPERTY FOR COUNTY PURPOSES, EXCLUDING BUSINESS
- 24 PERSONAL PROPERTY AND RAILROAD PERSONAL PROPERTY, AS OF JULY 1 OF THE
- 25 FISCAL YEAR PRECEDING THE FISCAL YEAR FOR WHICH THE CALCULATION OF
- 26 STATE PUBLIC SAFETY AID IS MADE UNDER THIS SECTION.
- 27 (3) "ELIGIBLE COUNTY" MEANS A COUNTY THAT SPENDS OVER 0.25% OF
- 28 THE COUNTY'S WEALTH ON ELIGIBLE EXPENDITURES.

- 1 (4) "ELIGIBLE EXPENDITURES" MEANS A COUNTY'S OPERATING
- 2 EXPENSES, DURING THE SECOND PRIOR FISCAL YEAR FOR WHICH PUBLIC SAFETY

- 13 EXCEED 15% OF AN ELIGIBLE COUNTY'S ELIGIBLE EXPENDITURES.
- 14 (7) "WEALTH" MEANS THE SUM OF NET TAXABLE INCOME AND
- 15 ASSESSED VALUE OF TAXABLE PROPERTY.
- 16 (B) THERE IS A STATE PUBLIC SAFETY AID PROGRAM.
- 17 (C) (1) THE SECRETARY OF BUDGET AND MANAGEMENT SHALL:
- 18 (I) AUTHORIZE THE PAYMENT OF FUNDS UNDER THIS SECTION;

- 20 (II) DETERMINE WHICH COUNTIES ARE ELIGIBLE COUNTIES AND

- 28 (E) (1) IN FISCAL YEAR 2004 ONLY, EACH ELIGIBLE COUNTY SHALL RECEIVE
- 29 20% OF THE ELIGIBLE COUNTY'S PUBLIC SAFETY GRANT.
- 30 (2) IN FISCAL YEAR 2005 ONLY, EACH ELIGIBLE COUNTY SHALL RECEIVE
- 31 40% OF THE ELIGIBLE COUNTY'S PUBLIC SAFETY GRANT.
- 32 (3) IN FISCAL YEAR 2006 ONLY, EACH ELIGIBLE COUNTY SHALL RECEIVE
- 33 60% OF THE ELIGIBLE COUNTY'S PUBLIC SAFETY GRANT.
- 34 (4) IN FISCAL YEAR 2007 ONLY, EACH ELIGIBLE COUNTY SHALL RECEIVE
- 35 80% OF THE ELIGIBLE COUNTY'S PUBLIC SAFETY GRANT.

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 2 October 1, 2002.
