2 Medical Assistance - Hospitals - Off-Site Community-Based Mental Health 3 Services

- 4 FOR the purpose of requiring the Department of Health and Mental Hygiene to adopt
- 5 certain regulations for the reimbursement of certain facilities under the Medical
- 6 Assistance Program; requiring that a hospital providing mental health services
- at an off-site, community-based mental health center prior to a certain date be
- 8 subject to certain rates and provisions of law under certain circumstances; and
- 9 generally relating to off-site, community-based mental health services provided
- 10 by a hospital.
- 11 BY repealing and reenacting, with amendments,

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:

18 Article - Health - General

19 15-105.

- 20 (a) The Department shall adopt rules and regulations for the reimbursement
- 21 of providers under the Program. However, except for an invoice that must be
- 22 submitted to a Medicare intermediary or Medicare carrier for an individual who may
- 23 have both Medicare and Medicaid coverage, payment may not be made for an invoice
- 24 that is received more than 1 year after the dates of the services given.
- 25 (b) A provider who fails to submit an invoice within the required time may not
- 26 recover the amount later from the Program recipient.
- 27 (c) The Department shall adopt regulations for the reimbursement of
- 28 specialty outpatient treatment and diagnostic services rendered to Program

- 1 recipients at a freestanding clinic owned and operated by a hospital that is under a 2 capitation agreement approved by the Health Services Cost Review Commission. 3 Except as provided in subparagraph (ii) of this paragraph, the 4 reimbursement rate under paragraph (1) of this subsection shall be set according to 5 Medicare standards and principles for retrospective cost reimbursement as described 6 in 42 CFR Part 413 or on the basis of charges, whichever is less. 7 The reimbursement rate for a hospital that has transferred 8 outpatient oncology, diagnostic, rehabilitative, and digestive disease services to an 9 off-site facility prior to January 1, 1999 shall be set according to the rates approved 10 by the Health Services Cost Review Commission if: 11 1. The transfer of services was due to zoning restrictions at 12 the hospital campus; 13 2. The off-site facility is surveyed as part of the hospital for 14 purposes of accreditation by the Joint Commission on the Accreditation of Health 15 Care Organizations; and 16 The hospital notifies the Health Services Cost Review 3. 17 Commission in writing by July 1, 1999 that the hospital would like the services 18 provided at the off-site facility subject to Title 19, Subtitle 2 of this article. 19 (d) (1) THE DEPARTMENT SHALL ADOPT REGULATIONS FOR THE 20 REIMBURSEMENT OF OUTPATIENT MENTAL HEALTH SERVICES PROVIDED AT AN 21 OFF-SITE, COMMUNITY-BASED MENTAL HEALTH CENTER BY A HOSPITAL. 22 EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS (I) 23 PARAGRAPH, THE REIMBURSEMENT UNDER PARAGRAPH (1) OF THIS SUBSECTION 24 SHALL BE SET ACCORDING TO MEDICARE STANDARDS AND PRINCIPLES. 25 THE REIMBURSEMENT RATE FOR A HOSPITAL PROVIDING (II)26 MENTAL HEALTH CARE SERVICES AT AN OFF-SITE, COMMUNITY-BASED MENTAL 27 HEALTH CENTER BEFORE JANUARY 1, 1997 SHALL BE SET ACCORDING TO THE RATES 28 ESTABLISHED BY THE HEALTH SERVICES COST REVIEW COMMISSION IF: THE OFF-SITE FACILITY IS SURVEYED AS PART OF THE 29 30 HOSPITAL FOR PURPOSES OF ACCREDITATION BY THE JOINT COMMISSION ON THE 31 ACCREDITATION OF HEALTH CARE ORGANIZATIONS; AND THE HOSPITAL NOTIFIES THE HEALTH SERVICES COST 32 2.
- 33 REVIEW COMMISSION IN WRITING ON OR BEFORE JULY 1, 2002 THAT THE HOSPITAL
- 34 WOULD LIKE THE SERVICES PROVIDED AT THE OFF-SITE FACILITY SUBJECT TO
- 35 TITLE 19, SUBTITLE 2 OF THIS ARTICLE.
- This section has no effect if its operation would cause this State to lose any 36 (E)
- 37 federal funds.

- $1\,$ SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 2 effect June 1, 2002.
