- Creation of a State Debt St. Mary's County Patuxent River Naval Air
  Museum and Visitors Center
- 4 FOR the purpose of authorizing the creation of a State Debt not to exceed \$500,000,
- 5 the proceeds to be used for a grant to the Board of County Commissioners of St.
- 6 Mary's County for certain development or improvement purposes; providing for
- 7 disbursement of the loan proceeds, subject to a requirement that the grantee
- 8 provide and expend a matching fund; and providing generally for the issuance
- 9 and sale of bonds evidencing the loan.

## 10~ SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 11 MARYLAND, That:
- 12 (1) The Board of Public Works may borrow money and incur indebtedness on
- 13 behalf of the State of Maryland through a State loan to be known as the St. Mary's
- 14 County Patuxent River Naval Air Museum and Visitors Center Loan of 2002 in a
- 15 total principal amount equal to the lesser of (i) \$500,000 or (ii) the amount of the
- 16 matching fund provided in accordance with Section 1(5) below. This loan shall be
- 17 evidenced by the issuance, sale, and delivery of State general obligation bonds
- 18 authorized by a resolution of the Board of Public Works and issued, sold, and
- 19 delivered in accordance with §§ 8-117 through 8-124 of the State Finance and
- 20 Procurement Article and Article 31, § 22 of the Code.
- 21 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 22 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 23 § 8-122 of the State Finance and Procurement Article.
- 24 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 25 and first shall be applied to the payment of the expenses of issuing, selling, and
- 26 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 27 shall be credited on the books of the Comptroller and expended, on approval by the
- 28 Board of Public Works, for the following public purposes, including any applicable
- 29 architects' and engineers' fees: as a grant to the Board of County Commissioners of St.
- 30 Mary's County (referred to hereafter in this Act as "the grantee") for the planning,
- 31 design, construction, renovation, reconstruction, and capital equipping of the
- 32 buildings and permanent exhibits of the Patuxent River Naval Air Museum and

- 1 Visitors Center, a multi-phase, multi-year project, to be located adjacent to the
- 2 Patuxent River Naval Air Station in Lexington Park, featuring interactive exhibits
- 3 and hands-on learning experiences for young people, opening a window into the
- 4 high-technology frontiers explored at Patuxent River, and stimulating interest in
- 5 technology careers and education.
- 6 (4) An annual State tax is imposed on all assessable property in the State in
- 7 rate and amount sufficient to pay the principal of and interest on the bonds, as and
- 8 when due and until paid in full. The principal shall be discharged within 15 years
- 9 after the date of issuance of the bonds.
- 10 (5) Prior to the payment of any funds under the provisions of this Act for the
- 11 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 12 matching fund. No part of the grantee's matching fund may be provided, either
- 13 directly or indirectly, from funds of the State, whether appropriated or
- 14 unappropriated. No part of the fund may consist of real property, in kind
- 15 contributions, or funds expended prior to the effective date of this Act. In case of any
- 16 dispute as to the amount of the matching fund or what money or assets may qualify
- 17 as matching funds, the Board of Public Works shall determine the matter and the
- 18 Board's decision is final. The grantee has until June 1, 2004, to present evidence
- 19 satisfactory to the Board of Public Works that a matching fund will be provided. If
- 20 satisfactory evidence is presented, the Board shall certify this fact and the amount of
- 21 the matching fund to the State Treasurer, and the proceeds of the loan equal to the
- 22 amount of the matching fund shall be expended for the purposes provided in this Act.
- 23 Any amount of the loan in excess of the amount of the matching fund certified by the
- 24 Board of Public Works shall be canceled and be of no further effect.
- 25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
- 26 effect June 1, 2002.
