	(2) "COMMERCIAL ELECTRONIC MAIL" DOES NOT INCLUDE ELECTRONIC MAIL TO WHICH AN INTERACTIVE COMPUTER SERVICE PROVIDER HAS ATTACHED AN ADVERTISEMENT IN EXCHANGE FOR FREE USE OF AN ELECTRONIC MAIL ACCOUNT.
	(C) (1) "INTERACTIVE COMPUTER SERVICE PROVIDER" MEANS AN INFORMATION SERVICE, SYSTEM, OR ACCESS SOFTWARE PROVIDER THAT PROVIDES OR ENABLES COMPUTER ACCESS BY MULTIPLE USERS TO A COMPUTER SERVICE.
	(2) "INTERACTIVE COMPUTER SERVICE PROVIDER" INCLUDES A SERVICE OR SYSTEM THAT PROVIDES ACCESS TO THE INTERNET AND SYSTEMS OPERATED OR SERVICES OFFERED BY A LIBRARY OR EDUCATIONAL INSTITUTION.

22 23 24 25 26	(B) (A) THIS SECTION APPLIES TO A COMMERCIAL ELECTRONIC MAIL MESSAGE SENT FROM A COMPUTER LOCATED IN THE STATE OR TO AN ELECTRONIC MAIL ADDRESS THAT THE SENDER KNOWS OR HAS REASON TO KNOW IS HELD BY A RESIDENT OF THE STATE DOES NOT APPLY TO AN INTERACTIVE COMPUTER SERVICE PROVIDER OR A TELECOMMUNICATION UTILITY TO THE EXTENT THAT THE INTERACTIVE COMPUTER SERVICE PROVIDER OR THE TELECOMMUNICATION UTILITY MERELY HANDLES, RETRANSMITS, OR CARRIES A TRANSMISSION OF COMMERCIAL ELECTRONIC MAIL.

-	(1) MISREPRESENTS OR OBSCURES ANY INFORMATION RELATING TO THE POINT OF ORIGIN OR TRANSMISSION PATH OF THE COMMERCIAL ELECTRONIC MAIL MESSAGE; OR
	(2) IS FROM A COMPUTER IN THE STATE OR IS SENT TO AN ELECTRONIC MAIL ADDRESS THAT THE SENDER KNOWS OR SHOULD HAVE KNOWN IS HELD BY A RESIDENT OF THE STATE; AND

1 2	(2) (I) USES A THIRD PARTY'S INTERNET DOMAIN NAME OR ELECTRONIC MAIL ADDRESS WITHOUT THE PERMISSION OF THE THIRD PARTY;
	(II) CONTAINS FALSE OR MISLEADING INFORMATION IN ABOUT THE SUBJECT LINE ORIGIN OR THE TRANSMISSION PATH OF THE COMMERCIAL ELECTRONIC MAIL; OR
	(III) CONTAINS FALSE OR MISLEADING INFORMATION IN THE SUBJECT LINE THAT HAS THE CAPACITY, TENDENCY, OR EFFECT OF DECEIVING THE RECIPIENT.

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 2 October 1, 2002.
