A BILL ENTITLED

1 AN ACT concerning

2 **Juvenile Causes - Facilities Used for Detention - Accommodation of**
3 **Children Awaiting Placement After Disposition**

4 FOR the purpose of prohibiting a child from being accommodated in a facility used for
5 detention for more than a certain period of time after the court has made a
6 disposition on a certain petition except under certain circumstances; authorizing
7 the court to order that a child be accommodated in a facility used for detention
8 for a specified period of time under certain circumstances; authorizing the court
9 to extend the period of time for which a certain child may be accommodated in a
10 facility used for detention; requiring the Department of Juvenile Justice to make
11 a certain report; and generally relating to the accommodation of a child in a
12 facility used for detention after disposition.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
4 MARYLAND, That the Laws of Maryland read as follows:

5 **Article - Courts and Judicial Proceedings**

6 3-8A-01.

7 (l) "Detention" means the temporary care of children who, pending court
8 disposition, require secure custody for the protection of themselves or the community,
9 in physically restricting facilities.

10 3-8A-15.

11 (K) (1) EXCEPT AS PROVIDED IN PARAGRAPHS (2) AND (3) OF THIS
12 SUBSECTION, A CHILD MAY NOT BE ACCOMMODATED IN A FACILITY USED FOR
13 DETENTION FOR THE SPECIFIC ACT FOR WHICH THE CHILD HAS BEEN ADJUDICATED
14 DELINQUENT FOR MORE THAN 15 DAYS AFTER THE COURT MAKES A DISPOSITION ON
15 A PETITION UNDER § 3-8A-19 OF THIS SUBTITLE.

16 (2) THE COURT MAY ORDER THAT A CHILD BE ACCOMMODATED IN A
17 FACILITY USED FOR DETENTION FOR THE SPECIFIC ACT FOR WHICH THE CHILD HAS
18 BEEN ADJUDICATED DELINQUENT FOR A SPECIFIED PERIOD OF TIME NOT TO
19 EXCEED 45 DAYS FROM THE DATE OF DISPOSITION UPON A FINDING THAT
20 ACCOMMODATION IN THE FACILITY IS NECESSARY FOR THE APPROPRIATE
21 PLACEMENT OF THE CHILD.

22 (3) THE COURT MAY EXTEND THE PERIOD OF TIME SPECIFIED IN
23 PARAGRAPH (2) OF THIS SUBSECTION IN INCREMENTS OF NOT MORE THAN 30 DAYS
24 FOR A CHILD FOR WHOM THE DISPOSITION IS PLACEMENT IN A SECURE FACILITY.

26 (d) (1) In making a disposition on a petition under this subtitle, the court
27 may:

28 (i) Place the child on probation or under supervision in his own
29 home or in the custody or under the guardianship of a relative or other fit person,
30 upon terms the court deems appropriate;

31 (ii) Subject to the provisions of paragraph (2) of this subsection,
32 commit the child to the custody or under the guardianship of the Department of
33 Juvenile Justice, the Department of Health and Mental Hygiene, or a public or
34 licensed private agency on terms that the court considers appropriate to meet the
35 priorities set forth in § 3-8A-02 of this subtitle, including designation of the type of
36 facility where the child is to be accommodated, until custody or guardianship is
37 terminated with approval of the court or as required under § 3-8A-24 of this subtitle;
38 or

1 (iii) Order the child, parents, guardian, or custodian of the child to
2 participate in rehabilitative services that are in the best interest of the child and the
3 family.

4 (2) A child committed under paragraph (1)(ii) of this subsection may not:

5 (I) [be] BE accommodated in a facility that has reached budgeted
6 capacity if a bed is available in another comparable facility in the State, unless the
7 placement to the facility that has reached budgeted capacity has been recommended
8 by the Department of Juvenile Justice; OR

9 (II) EXCEPT AS PROVIDED IN § 3-8A-15(K) OF THIS SUBTITLE, BE
10 ACCOMMODATED IN A FACILITY USED FOR DETENTION.

11 (3) The court shall consider any oral address made in accordance with §
12 11-403 of the Criminal Procedure Article or any victim impact statement, as
13 described in § 11-402 of the Criminal Procedure Article, in determining an
14 appropriate disposition on a petition.

15 SECTION 2. AND BE IT FURTHER ENACTED, That the Department of
16 Juvenile Justice shall report to the General Assembly on or before July 1, 2003, in
17 accordance with § 2-1246 of the State Government Article, on the implementation of
18 this Act.

19 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
20 October 1, 2002.
