4 FOR the purpose of redistricting the school board districts of Prince George's County;
5 making this Act an emergency measure; and generally relating to the school
6 board districts of Prince George's County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That Section(s) 3-1001 of Article - Education of the Annotated Code of
19 Maryland be repealed.

20 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
21 read as follows:

24 (A) THE DESCRIPTIONS OF SCHOOL BOARD DISTRICTS IN THIS SECTION ARE
25 TO THE ELECTION DISTRICT AND PRECINCT BOUNDARIES AS REVIEWED AND
26 CERTIFIED BY THE PRINCE GEORGE'S COUNTY BOARD OF ELECTIONS OR THEIR
27 DESIGNEES BEFORE THEY WERE REPORTED TO THE UNITED STATES BUREAU OF

1 THE CENSUS AS PART OF THE 2000 CENSUS REDISTRICTING DATA PROGRAM AND AS
2 THOSE ELECTION DISTRICT AND PRECINCT LINES ARE SPECIFICALLY SHOWN ON
3 THE PUBLIC LAW 94-171 CENSUS BLOCK MAPS PROVIDED BY THE UNITED STATES
4 BUREAU OF THE CENSUS.

5 (B) SCHOOL BOARD DISTRICT I CONSISTS OF:

- 6 (1) ELECTION DISTRICT 1;
- 7 (2) ELECTION DISTRICT 10;
- 8 (3) ELECTION DISTRICT 14, PRECINCT 9; AND
- 9 (4) ELECTION DISTRICT 21, PRECINCTS 4, 5, AND 14.

10 (C) SCHOOL BOARD DISTRICT II CONSISTS OF:

- 11 (1) ELECTION DISTRICT 2, PRECINCT 5;
- 12 (2) ELECTION DISTRICT 14, PRECINCTS 2 AND 8;
- 13 (3) ELECTION DISTRICT 16, PRECINCT 1;
- 14 (4) ELECTION DISTRICT 19, PRECINCTS 1, 2, 4, AND 5;
- 15 (5) ELECTION DISTRICT 21, PRECINCTS 1, 2, 3, 6 THROUGH 11, 13, 15, 16,
16 AND 17; AND

17 (6) THAT PART OF ELECTION DISTRICT 21, PRECINCT 12 THAT IS
18 GENERALLY NORTH OF A LINE THAT BEGINS AT THE CENTER OF THE INTERSECTION
19 OF CLAGETT ROAD AND CLAGETT-PINE WAY AND RUNS ALONG THE CENTER OF
20 CLAGETT-PINE WAY TO THE INTERSECTION WITH PINEWAY, THEN IN A NORTHERLY
21 DIRECTION ALONG THE CENTER OF PINEWAY UNTIL PINEWAY INTERSECTS WITH
22 BALTIMORE AVENUE.

23 (D) SCHOOL BOARD DISTRICT III CONSISTS OF:

- 24 (1) ELECTION DISTRICT 16, PRECINCTS 2 THROUGH 5;
- 25 (2) ELECTION DISTRICT 17;
- 26 (3) ELECTION DISTRICT 19, PRECINCT 3; AND

27 (4) THAT PART OF ELECTION DISTRICT 21, PRECINCT 12 THAT IS
28 GENERALLY SOUTH OF A LINE THAT BEGINS AT THE CENTER OF THE INTERSECTION
29 OF CLAGETT ROAD AND CLAGETT-PINE WAY AND RUNS ALONG THE CENTER OF
30 CLAGETT-PINE WAY TO THE INTERSECTION WITH PINEWAY, THEN IN A NORTHERLY
31 DIRECTION ALONG THE CENTER OF PINEWAY UNTIL PINEWAY INTERSECTS WITH
32 BALTIMORE AVENUE.

33 (E) SCHOOL BOARD DISTRICT IV CONSISTS OF:

- 1 (1) ELECTION DISTRICT 2, PRECINCTS 1 THROUGH 4 AND 6 THROUGH 10;
 - 2 (2) ELECTION DISTRICT 13, PRECINCTS 2 AND 17;
 - 3 (3) ELECTION DISTRICT 18, PRECINCTS 2, 3, 5, 7, AND 8; AND
 - 4 (4) ELECTION DISTRICT 20, PRECINCTS 1, 2, 3, 5, 6, 7, 9, 10, AND 11.
- 5 (F) SCHOOL BOARD DISTRICT V CONSISTS OF:
- 6 (1) ELECTION DISTRICT 3, PRECINCTS 2, 3, AND 4;
 - 7 (2) ELECTION DISTRICT 7;
 - 8 (3) ELECTION DISTRICT 14, PRECINCTS 1, 3 THROUGH 7, AND 10; AND
 - 9 (4) ELECTION DISTRICT 15, PRECINCT 2.
- 10 (G) SCHOOL BOARD DISTRICT VI CONSISTS OF:
- 11 (1) ELECTION DISTRICT 6, PRECINCT 20;
 - 12 (2) ELECTION DISTRICT 13, PRECINCTS 1 AND 3 THROUGH 16;
 - 13 (3) ELECTION DISTRICT 18, PRECINCTS 1, 4, 6, 9, 10, AND 11; AND
 - 14 (4) ELECTION DISTRICT 20, PRECINCTS 4 AND 8.
- 15 (H) SCHOOL BOARD DISTRICT VII CONSISTS OF:
- 16 (1) ELECTION DISTRICT 6, PRECINCTS 1, 3 THROUGH 7, 10, 11, 12, 15
17 THROUGH 19, 21, 22, AND 23; AND
 - 18 (2) ELECTION DISTRICT 9, PRECINCTS 3 AND 9.
- 19 (I) SCHOOL BOARD DISTRICT VIII CONSISTS OF:
- 20 (1) ELECTION DISTRICT 6, PRECINCTS 2, 8, 9, 13, AND 14;
 - 21 (2) ELECTION DISTRICT 9, PRECINCTS 2 AND 5; AND
 - 22 (3) ELECTION DISTRICT 12.
- 23 (J) SCHOOL BOARD DISTRICT IX CONSISTS OF:
- 24 (1) ELECTION DISTRICT 3, PRECINCT 1;
 - 25 (2) ELECTION DISTRICT 4;
 - 26 (3) ELECTION DISTRICT 5;
 - 27 (4) ELECTION DISTRICT 8;

1 (5) ELECTION DISTRICT 9, PRECINCTS 1, 4, 6, 7, 8, 10, AND 11;

4 SECTION 3. AND BE IT FURTHER ENACTED, That this Act is an
5 emergency measure, is necessary for the immediate preservation of the public health
6 or safety, has been passed by a ye and nay vote supported by three-fifths of all the
7 members elected to each of the two Houses of the General Assembly, and shall take
8 effect from the date it is enacted.
