UPON EJECTMENT, THE PLAINTIFF OR HOLDER OF A GROUND RENT 22 (1) 23 IS ENTITLED TO REIMBURSEMENT FOR: 24 (I) **RECORDING FEES:** 25 (II)ATTORNEY'S FEES NOT TO EXCEED \$400; EXPENSES INCURRED IN THE PUBLICATION AND SERVICE OF 26 (III)

- 1 (IV) REASONABLE FEES FOR A NECESSARY TITLE SEARCH; AND
- 2 (V) TAXES, INCLUDING INTEREST AND PENALTIES, ARISING AFTER
- 3 THE DATE OF SALE THAT HAVE BEEN PAID BY THE PLAINTIFF OR HOLDER OF A
- 4 GROUND RENT.
- 5 (2) THE PLAINTIFF OR HOLDER OF A GROUND RENT IS ENTITLED TO
- 6 REIMBURSEMENT FOR EXPENSES INCURRED IN PREPARATION FOR ANY ACTION FOR
- 7 EJECTMENT, NOT TO EXCEED \$100.
- 8 (C) EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, THE
- 9 PLAINTIFF OR HOLDER OF A GROUND RENT IS NOT ENTITLED TO REIMBURSEMENT
