2 Agriculture - Crimes - Farm Product and Research Protection Act

- 3 FOR the purpose of prohibiting a person from willfully and maliciously damaging or
- 4 destroying an agricultural operation or product; establishing certain criminal
- 5 and civil penalties for the willful and malicious damage or destruction of an
- 6 agricultural operation or product; defining certain terms; and generally relating
- 7 to the damage or destruction of an agricultural operation or product.

- Section 10-1601 to be under the new subtitle "Subtitle 16. Destruction of

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

16 Article - Agriculture

17 SUBTITLE 16. DESTRUCTION OF AGRICULTURAL OPERATIONS AND PRODUCTS.

- 19 (A) (1) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
- 20 INDICATED.
- 21 (2) "AGRICULTURAL OPERATION" MEANS LAND, BUILDINGS, AND
- 22 EQUIPMENT OWNED OR LEASED BY A FARMER, PRIVATE RESEARCH FACILITY,
- 23 UNIVERSITY, OR ANY FEDERAL, STATE, OR LOCAL GOVERNMENT AGENCY, USED IN
- 24 THE PRODUCTION OF AN AGRICULTURAL PRODUCT.

- 1 (3) "AGRICULTURAL PRODUCT" HAS THE MEANING STATED IN § 10-601 2 OF THIS TITLE.
- 3 (B) A PERSON MAY NOT WILLFULLY OR MALICIOUSLY DAMAGE OR DESTROY 4 AN AGRICULTURAL OPERATION OR PRODUCT.
- 5 (C) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY AND ON 6 CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 1 YEAR OR A FINE NOT 7 EXCEEDING \$5,000 OR BOTH.
- 8 (D) IN ADDITION TO ANY OTHER FINES OR PENALTIES PROVIDED FOR A
- 9 VIOLATION OF THIS SECTION, A PERSON CONVICTED OF THE UNLAWFUL
- 10 DESTRUCTION OF AN AGRICULTURAL OPERATION OR PRODUCT SHALL BE REQUIRED
- 11 TO COMPENSATE THE OWNER OF THE DAMAGED OR DESTROYED AGRICULTURAL
- 12 OPERATION OR PRODUCT AT TWICE THE MARKET VALUE OF THE AGRICULTURAL
- 13 OPERATION OR PRODUCT DAMAGED OR DESTROYED.
- 14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 15 October 1, 2002.
