A BILL ENTITLED

1 AN ACT concerning

2 **Creation of a State Debt - Carroll County Agriculture Center/Danele Shipley**  
3 **Memorial Arena**

4 FOR the purpose of authorizing the creation of a State Debt not to exceed \$350,000,  
5 the proceeds to be used as a grant to the Board of Directors of Carroll County  
6 Agriculture Center, Inc. for certain development or improvement purposes;  
7 providing for disbursement of the loan proceeds, subject to a requirement that  
8 the grantee provide and expend a matching fund; and providing generally for  
9 the issuance and sale of bonds evidencing the loan.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
11 MARYLAND, That:

12 (1) The Board of Public Works may borrow money and incur indebtedness on  
13 behalf of the State of Maryland through a State loan to be known as the Carroll  
14 County Agriculture Center/Danele Shipley Memorial Arena Loan of 2002 in a total  
15 principal amount equal to the lesser of (i) \$350,000 or (ii) the amount of the matching  
16 fund provided in accordance with Section 1(5) below. This loan shall be evidenced by  
17 the issuance, sale, and delivery of State general obligation bonds authorized by a  
18 resolution of the Board of Public Works and issued, sold, and delivered in accordance  
19 with §§ 8-117 through 8-124 of the State Finance and Procurement Article and  
20 Article 31, § 22 of the Code.

21 (2) The bonds to evidence this loan or installments of this loan may be sold as  
22 a single issue or may be consolidated and sold as part of a single issue of bonds under  
23 § 8-122 of the State Finance and Procurement Article.

24 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer  
25 and first shall be applied to the payment of the expenses of issuing, selling, and  
26 delivering the bonds, unless funds for this purpose are otherwise provided, and then  
27 shall be credited on the books of the Comptroller and expended, on approval by the  
28 Board of Public Works, for the following public purposes, including any applicable  
29 architects' and engineers' fees: as a grant to the Board of Directors of Carroll County  
30 Agriculture Center, Inc. (referred to hereafter in this Act as "the grantee") for the  
31 planning, design, construction, and capital equipping of an agricultural building to be  
32 used for agricultural and community activities.

1 (4) An annual State tax is imposed on all assessable property in the State in  
2 rate and amount sufficient to pay the principal of and interest on the bonds, as and  
3 when due and until paid in full. The principal shall be discharged within 15 years  
4 after the date of issuance of the bonds.

5 (5) Prior to the payment of any funds under the provisions of this Act for the  
6 purposes set forth in Section 1(3) above, the grantee shall provide and expend a  
7 matching fund. No part of the grantee's matching fund may be provided, either  
8 directly or indirectly, from funds of the State, whether appropriated or  
9 unappropriated. The fund may consist of real property, in kind contributions, and  
10 funds expended prior to the effective date of this Act. In case of any dispute as to the  
11 amount of the matching fund or what money or assets may qualify as matching funds,  
12 the Board of Public Works shall determine the matter and the Board's decision is  
13 final. The grantee has until June 1, 2004, to present evidence satisfactory to the  
14 Board of Public Works that a matching fund will be provided. If satisfactory evidence  
15 is presented, the Board shall certify this fact and the amount of the matching fund to  
16 the State Treasurer, and the proceeds of the loan equal to the amount of the matching  
17 fund shall be expended for the purposes provided in this Act. Any amount of the loan  
18 in excess of the amount of the matching fund certified by the Board of Public Works  
19 shall be canceled and be of no further effect.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take  
21 effect June 1, 2002.
