## Chapter 715 of the Acts of 2001

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 MARYLAND, That:

17 (5) Prior to the payment of any funds under the provisions of this Act for the

18 purposes set forth in Section 1(3) above, the grantee shall provide and expend a

19 matching fund. No part of the grantee's matching fund may be provided, either

20 directly or indirectly, from funds of the State, whether appropriated or

21 unappropriated. No part of the fund may consist of [real property,] in kind

22 contributions[,] or funds expended prior to the effective date of this Act. THE FUND

23 MAY CONSIST OF REAL PROPERTY. In case of any dispute as to the amount of the

1 matching fund or what money or assets may qualify as matching funds, the Board of

- 2 Public Works shall determine the matter and the Board's decision is final. The
- 3 grantee has until June 1, 2003, to present evidence satisfactory to the Board of Public
- 4 Works that a matching fund will be provided. If satisfactory evidence is presented, the
- 5 Board shall certify this fact and the amount of the matching fund to the State
- 6 Treasurer, and the proceeds of the loan equal to the amount of the matching fund
- 7 shall be expended for the purposes provided in this Act. Any amount of the loan in
- 8 excess of the amount of the matching fund certified by the Board of Public Works
- 9 shall be canceled and be of no further effect.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 11 effect June 1, 2002.
