1 AN ACT concerning

2 ~~State Retirement and Pension System - Estimate of Pension Benefits~~
3 ~~Teachers' Retirement System - Purchase of Service Credit - Refund~~

4 FOR the purpose of providing the Board of Trustees of the State Retirement and
5 Pension System with certain powers if the actual retirement benefit received by
6 a retiree is a certain percent lower than a certain estimate of benefits and the
7 retiree acted in reliance upon the estimate; providing for the application of this
8 Act; and generally relating to estimates of retirement benefits to retirees of the
9 State retirement and pension systems providing certain retirees with a refund of
10 certain assets used to purchase certain service credit plus interest at a certain
11 rate; requiring the Board of Trustees for the State Retirement and Pension
12 System to make certain adjustments to the retirement allowance of certain
13 retirees; requiring the Board of Trustees for the State Retirement and Pension
14 System to make certain adjustments to certain refunds; providing for the
15 termination of this Act; and generally relating to authorizing a certain refund of
16 assets used to purchase certain service credit plus interest for certain retirees of
17 the Teachers' Retirement System.

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 7 MARYLAND, That ~~the Laws of Maryland read as follows:~~

10 (A) ~~The Board of Trustees shall offer counseling about retirement benefits:~~

11 (1) ~~to the members, former members, and retirees of each State system;~~

12 ~~and~~

13 (2) ~~if a member, former member, or retiree consents, to an immediate~~

14 ~~family member.~~

15 (B) (1) ~~THIS SUBSECTION APPLIES IF THE BOARD OF TRUSTEES OR THE~~
 16 ~~STATE RETIREMENT AGENCY PROVIDES AN ESTIMATE OF RETIREMENT BENEFITS AS~~
 17 ~~A PART OF ITS COUNSELING WITHIN A YEAR BEFORE RETIREMENT, AND THE ACTUAL~~
 18 ~~BENEFIT IS LOWER THAN THE ESTIMATE BY MORE THAN 1%.~~

19 (2) ~~IF THE BOARD OF TRUSTEES FINDS THAT A RETIREE ACTED TO THE~~
 20 ~~RETIREE'S DETRIMENT WITH RESPECT TO AN ESTIMATE OF RETIREMENT BENEFITS~~

29 ~~SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be~~
 30 ~~construed retroactively and shall be applied to and interpreted to affect retirees of the~~
 31 ~~State retirement and pension systems who retired on or after January 1, 1999.~~

32 (a) Notwithstanding any other provision of law, a retiree of the Teachers'
 33 Retirement System who purchased no more than 4 years of service credit at full cost
 34 under the State Personnel and Pensions Article based on an incorrect estimate of the
 35 retiree's retirement benefits provided by the Board of Trustees for the State Retirement
 36 and Pension System or the State Retirement Agency may receive a refund of the

1 amount the retiree paid for the service credit plus interest at the rate of 4% per year
2 compounded annually to the date of refund if:

3 (1) the retiree purchased the service credit prior to July 1, 1999;

4 (2) the retiree retired on July 1, 1999;

5 (3) in purchasing the service credit based on the estimate received by the
6 Board of Trustees or the State Retirement Agency, the Board of Trustees finds that the
7 retiree acted to the retiree's detriment; and

8 (4) the retiree files an application for the refund on or before December 31,
9 2002.

10 (b) (1) The retirement allowance of a retiree who receives a refund under
11 subsection (a) of this section shall be adjusted by the Board of Trustees to reflect the
12 reduction in service credit resulting from the refund.

13 (2) The Board of Trustees shall calculate the amount that the retiree has
14 been overpaid based on the retiree's adjusted retirement allowance determined under
15 subsection (b)(1) of this section and reduce the retiree's refund by that amount.

16 SECTION ~~3~~. 2. AND BE IT FURTHER ENACTED, That this Act shall take
17 effect July 1, 2002. It shall remain effective for a period of 6 months and, at the end of
18 December 31, 2002, with no further action required by the General Assembly, this Act
19 shall be abrogated and of no further force and effect.
