2 Harness Racing - Takeout - Purses and Maryland Standardbred Race Fund

- 3 FOR the purpose of authorizing certain representatives of harness racing licensees,
- 4 owners, trainers, and breeders to allocate certain takeout moneys for purses and
- 5 the Maryland Standardbred Race Fund in accordance with a certain agreement,
- 6 notwithstanding certain other provisions; specifying that this Act does not alter
- 7 certain other takeout provisions; and generally relating to the allocation of
- 8 harness racing takeout.

- 18 (A) NOTWITHSTANDING § 11-617 OF THIS SUBTITLE, THE AMOUNT OF THE
- 19 TAKEOUT RELATING TO PURSES AND THE MARYLAND STANDARDBRED RACE FUND
- 20 RETAINED BY A HARNESS TRACK LICENSEE MAY BE ALLOCATED IN ACCORDANCE
- 21 WITH THE TERMS OF A WRITTEN AGREEMENT SIGNED BY THE AUTHORIZED
- 22 REPRESENTATIVES OF:
- 23 (1) THE LICENSEE:
- 24 (2) THE GROUP THAT REPRESENTS A MAJORITY OF THE OWNERS AND
- 25 TRAINERS LICENSED IN THE STATE WHEN THE AGREEMENT IS SIGNED; AND
- 26 (3) THE GROUP THAT REPRESENTS A MAJORITY OF THE BREEDERS IN 27 THE STATE WHEN THE AGREEMENT IS SIGNED.

- 1 (B) THIS SECTION DOES NOT ALLOW THE LICENSEE TO ALTER THE
- 2 MANDATORY TAKEOUT ALLOCATED TO THE COMMISSION FOR:
- 3 (1) STATE TAX; OR
- 4 (2) PAYMENT TO THE RACING FACILITY REDEVELOPMENT BOND FUND
- 5 FOR THE MARYLAND ECONOMIC DEVELOPMENT CORPORATION.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 7 October 1, 2002.
