20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 21 MARYLAND, That the Laws of Maryland read as follows:

## 1 Article - State Personnel and Pensions

- 2 21-307.
- 3 (a) For a permanent employee of a board of supervisors of elections who is a
- 4 member of the Employees' Retirement System or the Employees' Pension System, the
- 5 county where the member is employed shall:
- 6 (1) pay to the Board of Trustees the employer contributions otherwise 7 required to be made by the State on behalf of the member; and
- 8 (2) deduct from the compensation payable to the member and pay to the 9 Board of Trustees the required member contributions.
- 10 (b) (1) For a master in chancery or a master in juvenile causes who is
- 11 eligible for benefits under the Judges' Retirement System, the county where the
- 12 master serves shall pay to the Judges' Retirement System a portion of the employer
- 13 contributions required to be paid on behalf of the master as determined under
- 14 paragraph (2) of this subsection.
- 15 (2) The amount payable by a county for a master under this subsection is 16 the product of multiplying:
- 17 (i) the sum of the accrued liability contribution rate and the
- 18 normal contribution rate; and
- 19 (ii) the difference between the master's current earnable
- 20 compensation and the earnable compensation of the master as of January 1, 1989.
- 21 (c) For a member or retiree who transferred to the Teachers' Retirement
- 22 System of the State of Maryland from the Employees' Retirement System of the City
- 23 of Baltimore, the local system shall pay any excess of the amount to which the
- 24 member or retiree would have been entitled under the provisions of the local system
- 25 as they existed as of July 1, 1971, over the amount that is provided under this
- 26 Division II.
- 27 (d) For an additional employee or agent of the State Racing Commission who
- 28 is a member of the Employees' Pension System, the licensees of the State Racing
- 29 Commission shall pay the employer contributions otherwise required to be made by
- 30 the State on behalf of the member in the manner that the licensees pay the salary for
- 31 an additional employee or agent under the Maryland Horse Racing Act.
- 32 (e) For an employee of Dorchester County who is a member of the Employees'
- 33 Pension System or the Employees' Retirement System, Dorchester County shall pay
- 34 the employer contributions otherwise required to be made by the State on behalf of
- 35 the member.
- 36 (f) (1) For a member of the State Police Retirement System, the State shall
- 37 pay the cost of special death benefits under § 29-204(b)(1)(ii) of this article, including
- 38 the normal contribution rate and the accrued liability rate, up to the current

1 contribution rate for employers for federal old age, survivors, and disability 2 insurance. 3 Except as provided in paragraph (3) of this subsection, the members 4 shall pay the cost of the special death benefits that exceeds the current rate for 5 federal old age, survivors, and disability insurance. 6 The State shall pay the full costs of each special death benefit 7 applicable to each member whose death arises out of or in the course of actual 8 performance of duty. 9 For an employee of the Maryland Environmental Service who is a member 10 of the Employees' Retirement System or the Pension System for Employees, the 11 Maryland Environmental Service shall pay to the Board of Trustees the employer 12 contributions otherwise required to be made by the State on behalf of the member. 13 (h) For a court reporter for the Circuit Court for Charles County who is a 14 member of the Employees' Retirement System or the Employees' Pension System, the 15 County Commissioners of Charles County shall pay the employer contributions 16 otherwise required to be made by the State on behalf of the member. 17 Except as provided in subsection (j) of this section, the University 18 System of Maryland shall pay an annual accrued liability contribution equal to an amount that is sufficient to liquidate over not more than 5 years, the increase in the 20 accrued liability by means of annual payments that increase each year based on 21 actuarial assumptions adopted by the Board of Trustees on the recommendation of 22 the actuary. 23 (2) The University System of Maryland: 24 shall pay to the Board of Trustees the amount required under 25 this subsection on July 1 of each year until the increase in the accrued liability is paid 26 in full: and 27 may prepay all or a portion of the increase in the accrued 28 liability in accordance with a calculation approved by the Board of Trustees. The Medical System, as defined in § 13-301(k) of the Education 29 30 Article, shall pay an annual accrued liability contribution equal to an amount that is 31 sufficient to liquidate, over not more than 5 years, the increase in the accrued liability 32 determined under § 21-304(d)(5) of this subtitle that is attributable to the retirement 33 of Medical System university personnel, as defined in § 13-301(q) of the Education 34 Article, by means of annual payments that increase each year based on actuarial 35 assumptions adopted by the Board of Trustees on the recommendation of the actuary. 36 (2) The Medical System: 37 shall pay to the Board of Trustees the amount required under (i) 38 this subsection on July 1 of each year until the increase in the accrued liability is paid 39 in full: and

- 1 (ii) may prepay all or a portion of the increase in the accrued 2 liability in accordance with a calculation approved by the Board of Trustees.
- 3 (k) For each employee who is subject to the contributory pension benefit under
- 4 Title 23, Subtitle 2, Part II of this article, Frederick County shall pay the additional
- 5 liabilities that result from the contributory pension benefit according to a schedule of
- 6 amortization that is subject to the approval of the Board of Trustees.
- 7 (L) FOR EACH EMPLOYEE OF A PARTICIPATING GOVERNMENTAL UNIT THAT
- 8 INITIALLY ELECTS TO PROVIDE ITS EMPLOYEES WITH THE CONTRIBUTORY PENSION
- $9\,$  BENEFIT UNDER TITLE 23, SUBTITLE 2, PART II OF THIS ARTICLE BETWEEN JULY 1,
- 10 2002 AND DECEMBER 31, 2002, INCLUSIVE, THE PARTICIPATING GOVERNMENTAL
- 11 UNIT SHALL PAY THE ADDITIONAL LIABILITIES THAT RESULT FROM THE
- 12 CONTRIBUTORY PENSION BENEFIT ACCORDING TO ANY INCREASE IN THE NORMAL
- 13 COST PERCENTAGE PLUS A SCHEDULE OF AMORTIZATION THAT IS SUBJECT TO THE
- 14 APPROVAL OF THE BOARD OF TRUSTEES.

- 16 (a) This section applies only to a former member, member, retiree, or surviving
- 17 beneficiary of the Employees' Pension System who, while a member, was an employee
- 18 of a participating governmental unit that elected the contributory pension benefit for
- 19 its employees under § 31-116 of this article.
- 20 (b) Except as provided in subsection (c) of this section, a member who is
- 21 subject to the contributory pension benefit under Subtitle 2, Part II of this title may
- 22 purchase credit for eligibility service for the period of employment from July 1, 1998,
- 23 through the effective date of election of the member's participating employer, by
- 24 paying to the Board of Trustees:
- 25 (1) on or before June 30, [2000] 2003, the amount the member would
- 26 have been required to contribute for that period of employment; or
- 27 (2) on or after July 1, [2000] 2003, the amount the member would have
- 28 been required to contribute for that period of employment plus regular interest
- 29 compounded annually.
- 30 (c) If the member fails to make the payment as provided under subsection (b)
- 31 of this section, the Board of Trustees shall reduce actuarially the allowance payable to
- 32 a former member, retiree, or surviving beneficiary of a deceased member, former
- 33 member, or retiree.
- 34 31-116.
- 35 (a) On or before December 31, [1999] 2002, a participating governmental unit
- 36 may elect to provide its employees with the contributory pension benefit under Title
- 37 23 of this article as provided in this section by submitting its election on a form
- 38 provided by the State Retirement Agency.

- 1 (b) (1) If a participating governmental unit elects to provide its employees 2 with the contributory pension benefit under Title 23 of this article, an employee of the 3 participating governmental unit who is a member of the Employees' Pension System 4 shall be entitled to the benefits as provided in § 23-218 of this article, effective on the 5 later of July 1, 1998, or the date the employee became a member of the Employees' 6 Pension System, unless the employee transferred to the Employees' Pension System 7 after April 1, 1998.
- 8 (2) If an employee of a participating governmental unit transferred to 9 the Employees' Pension System after April 1, 1998, the employee is not subject to 10 Title 23, Subtitle 2, Part II of this article and is not entitled to the benefits as 11 provided in § 23-218 of this article.
- 12 (c) An election by a participating governmental unit under this section is 13 irrevocable.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October July 1, 2002.
