- 24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

(A) SUBJECT TO THE PROVISIONS OF THIS SECTION, THE BOARD MAY WAIVE
THE EDUCATION REQUIREMENTS OF § 4-302 OF THIS SUBTITLE FOR AN APPLICANT
FOR A GENERAL LICENSE TO PRACTICE DENTISTRY WHO DOES NOT HOLD A DEGREE
OF DOCTOR OF DENTAL SURGERY, DOCTOR OF DENTAL MEDICINE, OR THE
EQUIVALENT FROM A COLLEGE OR UNIVERSITY THAT IS AUTHORIZED BY ANY STATE
OR ANY PROVINCE OF CANADA TO GRANT THE DEGREE AND IS RECOGNIZED BY THE
BOARD UNDER § 4-302(D)(2) OF THIS SUBTITLE.

19 (B) THE BOARD MAY GRANT A WAIVER UNDER THIS SECTION ONLY IF:

20 (1) THE APPLICANT:

(I) HOLDS A DEGREE OF DOCTOR OF DENTAL SURGERY, DOCTOR
 OF DENTAL MEDICINE, OR AN EQUIVALENT DEGREE FROM A SCHOOL, COLLEGE, OR
 FACULTY OF DENTISTRY OTHER THAN ONE LOCATED IN THE UNITED STATES OR
 CANADA;

(II) HAS SUCCESSFULLY COMPLETED AT LEAST A 2-YEAR
PEDIATRIC DENTISTRY RESIDENCY PROGRAM AT A DENTAL SCHOOL OR A HOSPITAL
AUTHORIZED BY ANY STATE AND WHICH IS RECOGNIZED BY THE BOARD;

28 (III) EITHER IS A PEDIATRIC DENTAL FELLOW, OR HAS
29 SUCCESSFULLY COMPLETED A PEDIATRIC DENTAL FELLOWSHIP, AT THE
30 UNIVERSITY OF MARYLAND DENTAL SCHOOL;

(IV) IS CONTRACTUALLY OBLIGATED TO PROVIDE PEDIATRIC
 DENTAL SERVICES FOR AT LEAST 2 YEARS IN A PUBLIC HEALTH DENTAL CLINIC
 OPERATED BY THE STATE OR A COUNTY OR MUNICIPALITY OF THE STATE;

34 (V) IS FOUND TO BE OF GOOD MORAL CHARACTER AND
 35 PROFESSIONALLY COMPETENT; AND

1 (VI) MEETS ANY OTHER REQUIREMENTS THAT THE BOARD MAY 2 REASONABLY REQUIRE; AND

3 (2) THE HEALTH OFFICER OF THE PUBLIC HEALTH PROGRAM FOR
4 WHICH THE APPLICANT HAS CONTRACTUALLY AGREED TO PROVIDE AT LEAST 2
5 YEARS OF PEDIATRIC DENTAL SERVICES AND THE DEAN OF THE UNIVERSITY OF
6 MARYLAND DENTAL SCHOOL REQUEST THE WAIVER AND STATE THAT
7 CIRCUMSTANCES EXIST TO JUSTIFY GRANTING THE WAIVER.

8 (C) A GENERAL LICENSE TO PRACTICE DENTISTRY MAY BE GRANTED UNDER
9 THIS SECTION ONLY AFTER THE APPLICANT HAS SUCCESSFULLY PASSED AN
10 EXAMINATION GIVEN BY THE BOARD AS REQUIRED UNDER § 4-302(F)(1) OF THIS
11 SUBTITLE.

(D) A GENERAL LICENSE GRANTED UNDER THIS SECTION SHALL BE
SURRENDERED IMMEDIATELY TO THE BOARD IF THE LICENSEE FAILS, FOR ANY
REASON, TO FULLY SATISFY THE LICENSEE'S CONTRACTUAL OBLIGATIONS TO
PROVIDE PEDIATRIC DENTAL CARE IN THE PUBLIC HEALTH DENTAL CLINIC AS
REQUIRED UNDER SUBSECTION (B)(1)(IV) OF THIS SECTION.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 October 1, 2002.
