15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

16 MARYLAND, That the Laws of Maryland read as follows:

19 (a) This section applies to Frederick County.

20 (b) Notwithstanding any other provision of this article, the Board of County

21 Commissioners may overrule an action of the Frederick County planning commission

22 under §§ 3.05, 3.06, 3.07, and 3.08 of this article by a majority vote of the membership

23 of the Board of County Commissioners.

24 (c) (1) Notwithstanding § 4.07(a) of this article, the members of the board of 25 appeals may be appointed to terms of 1 to 3 years.

26 (2) The terms of the board of appeals shall be staggered.

1 (d) If a plat is approved and recorded in accordance with this article before the

2 transfer of land, § 5.05 of this article does not apply to the contract for sale or

3 negotiation for sale of property zoned industrial, commercial, or both industrial and

5 (E) (1) AN ORDINANCE OR AMENDMENT TO AN EXISTING ORDINANCE THAT
6 EFFECTS A COMPREHENSIVE CHANGE IN ZONING LAWS ADOPTED BY THE BOARD OF
7 COUNTY COMMISSIONERS MAY NOT TAKE EFFECT UNLESS THE ORDINANCE OR
8 AMENDMENT HAS BEEN SUBMITTED TO, AND APPROVED BY, THE VOTERS OF

11 (2) THE COST OF THE REFERENDUM, IF ANY, SHALL BE PAID BY THE 12 BOARD OF COUNTY COMMISSIONERS.

13(3)THE BOARD OF COUNTY COMMISSIONERS AND THE BOARD OF14SUPERVISORS OF ELECTIONS SHALL PROVIDE FOR AND HOLD THE REFERENDUM.

15(4)(I)IF A MAJORITY OF THE VOTES CAST ON THE QUESTION ARE16"FOR THE REFERRED LAW", THE ENACTMENT BECOMES EFFECTIVE ON THE DATE17SPECIFIED IN THE ENACTMENT.

18 (II) IF A MAJORITY OF THE VOTES CAST ON THE QUESTION ARE 19 "AGAINST THE REFERRED LAW", THE PROVISIONS OF THE ENACTMENT ARE OF NO 20 EFFECT.

SECTION 2. AND BE IT FURTHER ENACTED, That if any provision of this Act or the application thereof to any person or circumstance is held invalid for any reason in a court of competent jurisdiction, the invalidity does not affect other provisions or any other application of this Act which can be given effect without the invalid provision or application, and for this purpose the provisions of this Act are declared severable.

27 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 28 June 1, 2002. It shall remain effective for a period of 5 years and, at the end of May 29 31, 2007, with no further action required by the General Assembly, this Act shall be 30 abrogated and of no further force and effect.
