## A BILL ENTITLED

1 AN ACT concerning

## 2 Creation of a State Debt - Montgomery County - Maryland Avenue Extended

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$350,000,
- 4 the proceeds to be used as a grant to the Mayor and City Council of Rockville for
- 5 certain development or improvement purposes; providing for disbursement of
- 6 the loan proceeds, subject to a requirement that the grantee provide and expend
- a matching fund; and providing generally for the issuance and sale of bonds
- 8 evidencing the loan.

## 9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

10 MARYLAND, That:

- 11 (1) The Board of Public Works may borrow money and incur indebtedness on
- 12 behalf of the State of Maryland through a State loan to be known as the Montgomery
- 13 County Maryland Avenue Extended Loan of 2002 in a total principal amount equal
- 14 to the lesser of (i) \$350,000 or (ii) the amount of the matching fund provided in
- 15 accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale,
- 16 and delivery of State general obligation bonds authorized by a resolution of the Board
- 17 of Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
- 18 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 19 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 20 a single issue or may be consolidated and sold as part of a single issue of bonds under
- $21~\S~8\mbox{-}122$  of the State Finance and Procurement Article.
- 22 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 23 and first shall be applied to the payment of the expenses of issuing, selling, and
- 24 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 25 shall be credited on the books of the Comptroller and expended, on approval by the
- 26 Board of Public Works, for the following public purposes, including any applicable
- 27 architects' and engineers' fees: as a grant to the Mayor and City Council of Rockville
- 28 (referred to hereafter in this Act as "the grantee") for the design and construction of
- 20 (referred to include in this 7 fet as the grantee) for the design and construction of
- 29 extending Maryland Avenue between Middle Lane and Beall Avenue to consist of a
- 30 lane of traffic in both directions as a gateway to the entertainment corridor in
- 31 Rockville Town Center, consisting of pedestrian amenities, wide sidewalks,

- 1 landscaping, ornamental lighting, on-street parking and bike lanes, located in 2 Rockville.
- 3 (4) An annual State tax is imposed on all assessable property in the State in 4 rate and amount sufficient to pay the principal of and interest on the bonds, as and
- 5 when due and until paid in full. The principal shall be discharged within 15 years
- 6 after the date of issuance of the bonds.
- 7 (5) Prior to the payment of any funds under the provisions of this Act for the
- 8 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 9 matching fund. No part of the grantee's matching fund may be provided, either
- 10 directly or indirectly, from funds of the State, whether appropriated or
- 11 unappropriated. No part of the fund may consist of real property, in kind
- 12 contributions, or funds expended prior to the effective date of this Act. In case of any
- 13 dispute as to the amount of the matching fund or what money or assets may qualify
- 14 as matching funds, the Board of Public Works shall determine the matter and the
- 15 Board's decision is final. The grantee has until June 1, 2004, to present evidence
- $16\,$  satisfactory to the Board of Public Works that a matching fund will be provided. If
- 17 satisfactory evidence is presented, the Board shall certify this fact and the amount of
- 18 the matching fund to the State Treasurer, and the proceeds of the loan equal to the
- 19 amount of the matching fund shall be expended for the purposes provided in this Act.
- 20 Any amount of the loan in excess of the amount of the matching fund certified by the
- 21 Board of Public Works shall be canceled and be of no further effect.
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 23 June 1, 2002.
